RESOLUTION

1 WHEREAS, Dr. Robert S. Nelsen, the president of The 2 University of Texas-Pan American, is an outstanding educator and 3 administrator, and he is most deserving of special recognition for 4 his many notable accomplishments; and

5 WHEREAS, Raised on a cattle ranch in Montana, Robert Nelsen was the first person in his family to attend college; in order to 6 7 pay his tuition, he held a variety of jobs and at one point worked overnight as a janitor while attending classes during the day and 8 9 holding down another job at a sporting goods store; even then, he was forced by financial difficulties to leave school for a year, but 10 11 his wife, Jody, helped convince him to return to his studies; he 12 went on to earn bachelor's and master's degrees in political science from Brigham Young University and received his doctorate from the 13 14 Committee on Social Thought at the University of Chicago, studying with Nobel Laureate Saul Bellow and specializing in modern 15 16 literature, modern philosophy, and modern political theory; and

WHEREAS, Dr. Nelsen is fluent in Spanish and has published 17 his fiction in numerous literary journals; a Texas resident since 18 1990, he was a professor at The University of Texas at Dallas, where 19 20 he initiated the school's creative writing program and nurtured the 21 development of an arts and humanities curriculum; in addition, he won the Chancellor's Council Outstanding Teaching Award in 2005, 22 23 served five terms as head of the faculty senate, and held the position of vice provost; he then accepted a position as the 24
