RESOLUTION

- 1 WHEREAS, The citizens of Weatherford and Parker County lost a
- 2 greatly admired member of their community with the death of Jack
- 3 Borden on January 19, 2011, at the age of 102; and
- WHEREAS, Jack Borden was born near Weatherford on August 5,
- 5 1908, to John Samuel Borden and Bess Wallis; the son of
- 6 sharecroppers, he graduated from Weatherford College in 1931, and
- 7 he earned his law degree from The University of Texas in 1936; and
- 8 WHEREAS, Two years later, Mr. Borden was elected district
- 9 attorney of Parker County; during World War II, he served his nation
- 10 as a member of the Federal Bureau of Investigation for several
- 11 years, and he was a charter member of the Parker County Sheriff's
- 12 Posse when it was formed in 1947; and
- WHEREAS, A practicing attorney for more than three-quarters
- 14 of a century, Mr. Borden was one of the leading citizens of
- 15 Weatherford; he sat on the board of directors of First National Bank
- 16 of Weatherford from 1955 to 1977, and he was the city's mayor from
- 17 1960 to 1964; he continued to practice law until two days before his
- 18 death, regularly appearing in probate court, where he loved to
- 19 share stories with the judge; he was considered to be the oldest
- 20 member of the Texas Bar as well as the nation's oldest living former
- 21 FBI agent; and
- 22 WHEREAS, This outstanding Texan garnered many awards and
- 23 honors through the years; he received all three of Weatherford
- 24 College's highest awards, including Alumnus of the Year

- 1 Distinguished Alumnus, and the Carlos Hartnett Award; in 2008, he
- 2 was recognized as Texas' Outstanding Older Worker of the Year; he
- 3 was named Outstanding Citizen of Weatherford in 2005, and five
- 4 years later, a street was renamed Jack Borden Way in his honor; and
- 5 WHEREAS, An active member of First Baptist Church of
- 6 Weatherford since 1936, Mr. Borden served the congregation as a
- 7 deacon and chair of the board of deacons; he also taught Sunday
- 8 school for 25 years; and
- 9 WHEREAS, Mr. Borden enjoyed 66 years of marriage to the love
- 10 of his life, Edith Jordan Borden, who was renowned for her expertise
- 11 in Parker County history; he was also close to his many nieces and
- 12 nephews, including John Westhoff, with whom he shared a law
- 13 practice for nearly four decades; and
- WHEREAS, Known for his humility, intelligence, and honesty,
- 15 Jack Borden leaves behind a century-long legacy of loyalty and
- 16 service to the community in which he spent his entire life, and he
- 17 will forever be remembered by his family, friends, and fellow
- 18 citizens; now, therefore, be it
- 19 RESOLVED, That the House of Representatives of the 82nd Texas
- 20 Legislature hereby pay tribute to the life of Jack Borden and extend
- 21 sincere condolences to the members of his family: to his brother,
- 22 C. B. Borden; to his nephews, John Westhoff and his wife, Sue Ann,
- 23 Leo W. Tiberghian III, and Eddie Borden; to his nieces, Nancy Borden
- 24 O'Neal, Susie Borden Gandy, Traci Layman Brown, Terri Layman Short,

- 26 Westhoff; to his great-nephew, John Trenton Westhoff, his wife,
