6 graduated from Holmes High School and went on to earn her bachelor's

9 her 20-year career in medicine with her father's practice on the
10 east side of San Antonio, and she later joined the staff at Wilford
11 Hall Medical Center; after moving to California, she treated
12 patients in the state's penal system as a contract physician and

15 shared a passion for sailing with her husband, Phillip Donatto,
16 whom she met on a trip to Tahiti; devoted to her family, Dr. Donatto
17 encouraged her four younger sisters to excel, and she adored her
18 nieces and nephews, to whom she was a favorite aunt; she was a woman
19 of great compassion and gave generously to those in need; and

20 WHEREAS, Dana Donatto lived a caring and purposeful life, and
21 she will forever hold a treasured place in the hearts of those she
22 left behind; now, therefore, be it
