1 WHEREAS, A life made rich through meaningful service drew to
2 a close when Kathleen Jeanne Jones Gilles of Arlington died on
3 January 21, 2011, at the age of 77; and

4 WHEREAS, Born on October 26, 1933, in Dallas and raised in
5 Wellington, the former Jeanne Jones was the daughter of Dr. Charles
6 Jones, Jr., and Kathleen Patricia Hosack Jones; one of five
7 children, she enjoyed the companionship of a sister, Rosemary, and
8 three brothers, Charles, John, and Frank; and

9 WHEREAS, After attending Sacred Heart Academy in
10 Springfield, Illinois, Mrs. Gilles graduated from Saint Joseph
11 Hospital School of Nursing in Memphis, Tennessee; she worked for a
12 time as a registered nurse at Saint Paul's Hospital in Dallas, then
13 relocated to Midland, where she lived for most of her life; it was
14 there that she met her future husband, Gilbert Joseph Gilles, Jr.;
15 the couple married on January 15, 1955, and shared nearly 40
16 rewarding years together, until Mr. Gilles's passing in 1994; and

17 WHEREAS, Over the course of a distinguished 23-year career at
18 Midland Memorial Hospital, Mrs. Gilles served as a nursing
19 supervisor and as a nurse administrator in obstetrics, the
20 emergency department, and the pharmacy; in 1982, she opened We Care
21 Home Health Agency with several colleagues, and she continued
22 working in the home health field until her retirement at age 74; she
23 moved to Arlington in 2002; and

24 WHEREAS, Mrs. Gilles was a devoted wife, mother, and

1 grandmother, and she treasured the time she spent with her family,
2 which grew to include 4 children and 11 grandchildren; a longtime
3 congregant of Saint Ann's Catholic Church, she enjoyed dancing,
4 playing bridge, and rooting for the Texas Longhorns; and

5 WHEREAS, Jeanne Gilles touched many lives during her time on
6 this earth, and she will forever hold a special place in the hearts
7 of those who knew and loved her; now, therefore, be it

8 RESOLVED, That the House of Representatives of the 82nd Texas
9 Legislature hereby pay tribute to the memory of Kathleen Jeanne
10 Jones Gilles and extend sincere sympathy to the members of her
11 family: to her children, Stephen J. Gilles and his wife, Stephanie,
12 R. Michele Purgason and her husband, Thomas, Kathleen J. Clymer,
13 and Susan G. Gilmore and her husband, Trey; to her grandchildren,
14 Emily, Sarah, Sophia, and Gabriella Gilles, Nicholas, Ashley, and
15 Michael Purgason, Taylor Clymer, and Will, Gibby, and Jackson
16 Gilmore; to her brother, Frank H. Jones, and his wife, Sharon; and
