- 1 WHEREAS, The office of justice of the peace, originally 2 created in 1362 by King Edward of England, and the office of 3 constable, created in 1215 by King John of England, were two of the
- 4 first offices established in the American colonies in 1620; and
- WHEREAS, Both offices were created by the Texas Constitution and play a vital role in the delivery of county government services;
- 7 and
- 8 WHEREAS, Justices of the peace are an integral part of the
- 9 Texas judiciary; they exercise jurisdiction in criminal
- 10 misdemeanor cases punishable by fine or sanctions and exercise
- 11 civil jurisdiction in matters in controversy under \$10,000; first
- 12 established as "grass roots" courts in 1836, when Texas became a
- 13 republic, they preside over those courts closest to the people; and
- 14 WHEREAS, Constables serve as officers of the court as
- 15 bailiffs, execute civil and criminal process issued by Texas
- 16 courts, and enforce criminal laws as certified peace officers; they
- 17 were first documented in Texas by Stephen F. Austin in 1823, when
- 18 Texas was still under Mexican rule; and
- WHEREAS, Established in 1945, the Justices of the Peace and
- 20 Constables Association of Texas represents the interests of Texas
- 21 justices of the peace and constables, as well as their clerks and
- 22 deputies; and
- 23 WHEREAS, The men and women who accept the responsibilities of
- 24 the offices of justice of the peace and constable contribute

- 1 immeasurably to the justice system, the safety of Texans, and the
- 2 peace and order of our society, and the dedication of a special day
- 3 at the Capitol to focus attention on these public officials
- 4 heightens awareness of the important contributions they make
- 5 benefiting citizens across the Lone Star State; now, therefore, be
- 6 it
- 7 RESOLVED, That the House of Representatives of the 82nd Texas
- 8 Legislature hereby recognize February 22, 2011, as Justices of the
- 9 Peace and Constables Day at the State Capitol; and, be it further
- 10 RESOLVED, That an official copy of this resolution be
- 11 prepared for the association as an expression of high regard from
- 12 the Texas House of Representatives.
