WHEREAS, Assigned to the 2nd Battalion, 4th Infantry
Regiment, 4th Brigade Combat Team, 10th Mountain Division,
Specialist Soltero was based at Fort Polk, Louisiana; he was killed
in action while bravely serving his nation in Afghanistan; and

WHEREAS, Omar Soltero was born on May 23, 1982, to Gustavo and 8 Maria Soltero; he knew as a child that he wanted to become a 9 soldier, and he realized his dream when he joined the army in 2000; 10 11 during his first period of enlistment, he was stationed with the 12 10th Mountain Division at Fort Drum, New York; he subsequently joined the New York National Guard in 2003 and the Texas National 13 14 Guard in 2004 before returning to active duty with the army in February 2010; in addition to serving in Afghanistan, he deployed 15 16 twice to Kosovo; and

WHEREAS, Among the numerous military awards conferred on Specialist Soltero were the Bronze Star, the Purple Heart, the Army Achievement Medal with four oak leaf clusters, and the National Defense Service Medal with a bronze star; moreover, he received the Afghanistan Campaign Medal with star device, the Kosovo Campaign Medal with bronze service star, and the Global War on Terrorism Service Medal; and

5 WHEREAS, Specialist Soltero embodied the highest standards 6 of the U.S. armed forces, and his valiant efforts and immense 7 sacrifice are deserving of honor by every American; now, therefore, 8 be it
