## RESOLUTION

- 1 WHEREAS, The citizens of Corpus Christi lost a beloved
- 2 educator and an admired jazz musician with the death of Edward
- 3 Galvan of Corpus Christi on February 15, 2011, at the age of 83; and
- WHEREAS, Eddie Galvan was born on August 19, 1927, to Rafael
- 5 and Virginia Galvan; his father gave him violin lessons, but he
- 6 wanted to be a horn player and snuck a saxophone home from school to
- 7 teach himself to play; and
- 8 WHEREAS, While still a young man, he and his brother Bobby
- 9 opened the Galvan Music Company and the Galvan Ballroom in Corpus
- 10 Christi, where together with their brothers Sammy and Ralph they
- 11 performed during the height of the swing era as the Galvan Brothers,
- 12 often accompanying such music legends as Duke Ellington, Stan
- 13 Kenton, Tommy Dorsey, and Gene Krupa; and
- WHEREAS, After graduating from Corpus Christi High School in
- 15 1945, Mr. Galvan earned an associate's degree at Del Mar College; he
- 16 went on to earn a bachelor's degree and a master's degree in music
- 17 from Texas College of Arts and Industries in 1952 and 1953,
- 18 respectively; and
- 19 WHEREAS, Mr. Galvan began his career in education as a
- 20 teacher in Premont in 1953, and three years later, he joined the
- 21 Corpus Christi Independent School District; from 1973 until he
- 22 retired from the district in 1985, he was the district's
- 23 coordinator of music and director of human resources; and
- 24 WHEREAS, An inspiring teacher who was known to his devoted

- 1 students as "Mr. G.," Mr. Galvan led the Battlin' Bucs band of Roy
- 2 Miller High School to many University Interscholastic League
- 3 victories; under his baton, the Bucs also won outstanding band
- 4 honors at Six Flags Over Texas and the Houston Baptist Music
- 5 Festivals; they received the Victor's Trophy at the 1968 Cotton
- 6 Bowl, and the following year, Mr. Galvan was invited to be guest
- 7 conductor at the Cotton Bowl Pageant; and
- 8 WHEREAS, After retiring from Corpus Christi ISD in 1985, Mr.
- 9 Galvan continued to teach as an associate professor of music at
- 10 Corpus Christi State University until 1991, when he was appointed
- 11 dean of music at Vidal M. Trevino School of Communications and Fine
- 12 Arts in Laredo, a position he held for eight years; and
- 13 WHEREAS, The dynamic Mr. Galvan also found time to serve as
- 14 vice president of the Band Division of the Texas Music Educators
- 15 Association and as president of the Texas Bandmasters Association;
- 16 from 1973 through 1994, he was a Port of Corpus Christi
- 17 commissioner; and
- WHEREAS, For more than four decades, Mr. Galvan performed as
- 19 the front man of the Eddie Galvan Orchestra, delighting audiences
- 20 throughout South Texas; he cofounded the Texas Jazz Festival, where
- 21 he was a headliner for many years, and in 2004, he and his brother
- 22 Bobby were inducted into the South Texas Music Walk of Fame; the
- 23 band hall at Roy Miller High School was renamed in his honor, and in
- 24 2008, he was inducted into the South Texas Region XIV Band Directors
- 25 Hall of Fame; and
- 26 WHEREAS, A gifted jazz musician and a dedicated teacher,
- 27 Eddie Galvan leaves behind a legacy that will long resonate in the

- 1 lives of his many friends and admirers throughout the state; now,
- 2 therefore, be it
- RESOLVED, That the House of Representatives of the 82nd Texas
- 4 Legislature hereby pay tribute to the memory of Edward Galvan and
- 5 extend sincere condolences to the members of his family: to his
- 6 wife, Nancy Galvan; to his children, Mary Grace Carroll and her
- 7 husband, Vernon, and Edward Overton Galvan, and their mother,
- 8 Catherine Marion Menger; to his grandchildren, Kathryn Bridget and
- 9 Patrick Edward; to his stepchildren, Jeffery Mark Brewer, his wife,
- 10 Joanna, and their son, Joseph, John Gordon Brewer, his wife,
- 11 Marcie, and their children, Kevin, Justin, Darby, Evan, and
- 12 Georgia, and Tava Marie Foret, her husband, David, and their sons,
- 13 Clinton, Trystan, and David; to his sisters, Patty Prezas and Mamie
- 14 Oliveira; to his brothers, Ralph Galvan, Jr., and his wife, Jeanne,
- 15 and Bobby Galvan and his wife, Alicia; and to his other relatives
- 16 and friends; and, be it further
- 17 RESOLVED, That an official copy of this resolution be
- 18 prepared for his family and that when the Texas House of
- 19 Representatives adjourns this day, it do so in memory of Eddie
- 20 Galvan.
