

R E S O L U T I O N

1           WHEREAS, The citizens of Hutto lost one of their most admired  
2 community leaders with the death of the Honorable Edmund G. Schmidt  
3 on February 21, 2011, at the age of 89; and

4           WHEREAS, A native of East Williamson County, Edmund Schmidt  
5 was born on January 5, 1922, the first of nine children of Rosa and  
6 F. H. Schmidt; he grew up tending to his family's farm and learning  
7 the grocery trade at his weekend job in Taylor; in 1942, he joined  
8 the U.S. Army, serving in a medical evacuation detachment on ships  
9 in the Pacific theater and in a field hospital in New Guinea; his  
10 outstanding efforts in behalf of his country earned him a number of  
11 honors, including two Bronze Star Medals; and

12           WHEREAS, Mr. Schmidt married the former Julia Hurta in 1942;  
13 the couple settled in Hutto in 1951 and opened Red & White Grocery,  
14 operating the thriving business for nearly four decades until 1990,  
15 when Mr. Schmidt opened a local chapter of Germania Insurance; and

16           WHEREAS, Dedicated to giving back to his fellow residents,  
17 Mr. Schmidt began his distinguished tenure in public office as a  
18 member of the city council, and he went on to serve as mayor for two  
19 decades; in later years, he continued his public service through  
20 his work with the zoning board of adjustment and the Hutto Education  
21 Foundation; and

22           WHEREAS, This esteemed Texan was a charter member of the  
23 local chamber of commerce and the Lions Club, where he had 55 years  
24 of perfect attendance and was recognized with the Melvin Jones

1 Fellowship Award; and

2 WHEREAS, The life of Edmund Schmidt stands as an outstanding  
3 example of positive civic engagement, and he leaves behind a record  
4 of service that his loved ones can remember with pride; now,  
5 therefore, be it

6 RESOLVED, That the House of Representatives of the 82nd Texas  
7 Legislature hereby pay tribute to the life of the Honorable Edmund  
8 G. Schmidt and extend deepest sympathy to the members of his family:  
9 to his wife of 69 years, Julia Schmidt; to his sons, Dennis Schmidt  
10 and his wife, Rosemary, and David Schmidt and his wife, Jessica; to  
11 his daughters, Jennifer Goodenow and her husband, Kenneth, and  
12 Corliss Powell and her husband, Ted; to his 12 grandchildren and his  
13 7 great-grandchildren; to his sisters, Rose Hardin, Nathalie  
14 Engling and her husband, Karl, and Shirley Halstead; and to his  
15 other relatives and friends; and, be it further

17 prepared for his family and that when the Texas House of  
18 Representatives adjourns this day, it do so in memory of the  
19 Honorable Edmund G. Schmidt.
