- 9 WHEREAS, Ms. Dailey worked as a management consultant and as
- 10 a counselor at a private school in Baltimore, where she also taught
- 11 ethnic dance, sewing, and knitting; she researched and wrote
- 12 history curriculum materials for elementary-age students, and she
- 13 owned and operated an interior design firm for several years; in
- 14 addition, she created and presented liturgical dances at churches
- 15 and prison facilities and was the director of a dance ministry
- 16 program; and
- WHEREAS, She reconnected with her high school sweetheart, Dr.
- 18 Maceo Crenshaw Dailey, Jr., at a class reunion, and the couple
- 19 married in 2003; she joined her husband in El Paso, and together
- 20 they founded Sweet Earth Flying Press and published Boy of the
- 21 Border, a children's book by Langston Hughes and Arna Bontemps
- 22 never previously made available to the public; Ms. Dailey wrote and
- 23 produced dramatic works and taught courses in writing, modern and
- 24 ethnic dance, and drama in the Ysleta Independent School District;

- 1 in addition, she established a business through which she sold the
- 2 hand-knitted clothing and accessories she created; and
- 3 WHEREAS, Active in her community, Ms. Dailey served on the
- 4 boards of Kids Excel El Paso, a nonprofit arts initiative that
- 5 brings dance into public schools, and the FEMAP Foundation, which
- 6 focuses on health, economic development, and education among
- 7 marginalized populations, and she served as chair of the FEMAP
- 8 annual fund-raiser; she offered knitting classes at a local women's
- 9 shelter and she was the cofounder of the Sandbox Empowerment Group,
- 10 which counseled women victims of abuse and provided them with
- 11 professional training; and
- WHEREAS, In all of her endeavors, Ms. Dailey enjoyed the love
- 13 and support of her husband, as well as her two sons, Jason and
- 14 Garth; and
- WHEREAS, Committed to opening the doors of opportunity for
- 16 others, Sondra Dailey will be deeply missed, but the grace,
- 17 creativity, and optimism with which she lived her life will forever
- 18 inspire all who had the good fortune to know her; now, therefore, be
