1           WHEREAS, The untimely passing of Danny Duggan of Cherokee on  
2 January 18, 2011, at the age of 59, brought a profound loss to his  
3 community and many loved ones; and

4           WHEREAS, Danny Duggan was born in Pecos on September 3, 1951,  
5 to Jerry and Mary Duggan; for much of his working life, he was  
6 associated with the Cherokee Home for Children, which was founded  
7 by the Cherokee Church of Christ in 1956; Mr. Duggan was a member of  
8 the church and served as the home's director of development from  
9 1982 to 1992; during that time, the organization expanded to  
10 include more housing, a library, and a conference center; and

11           WHEREAS, Mr. Duggan returned to the Cherokee Home for  
12 Children as executive director in 1998; he served in that capacity  
13 until his death, taking an active interest in the lives of the  
14 residents under his care; he was known for his warmth and compassion  
15 and for the strong faith that informed every aspect of his life; and

16           WHEREAS, In all of his endeavors, he enjoyed the love and  
17 support of his wife, Janiece, whom he married in 1970; together they  
18 were blessed with four children, Kaci, Jerrod, Ryan, and Malcom,  
19 and shared in the joy of welcoming six grandchildren into their  
20 family; and

21           WHEREAS, A devoted husband and father and an inspiring  
22 leader, Danny Duggan touched the hearts of countless people through  
23 the years, and he leaves behind a legacy that will forever be  
24 treasured by all those who knew and loved him; now, therefore, be it

1           RESOLVED, That the House of Representatives of the 82nd Texas  
2 Legislature hereby pay tribute to the life of Danny Duggan and  
3 extend sincere condolences to the members of his family: to his  
4 wife, Janiece; to his children, Kaci Morrison and her husband,  
5 Tommy, Jerrod Duggan and his wife, Kim, Ryan Duggan and his wife,  
6 Laci, and Malcom Duggan; to his grandchildren, Talli and Tori  
7 Morrison and Landon, Mason, Payton, and Preslee Duggan; to his
