1           WHEREAS, Jaime Barceleau of El Paso has been honored with the  
2 2011 Lifetime Achievement Award by the Rio Grande Branch of the  
3 National Association of Social Workers; and

4           WHEREAS, The organization presents its Lifetime Achievement  
5 Award to those individuals who have had an accomplished career in  
6 the field of social work and who have made a lasting impact on their  
7 community; over the course of more than three decades,  
8 Mr. Barceleau has forged an outstanding record of achievement while  
9 tirelessly working to improve the lives of his fellow citizens, and  
10 his efforts have greatly benefited the city of El Paso; and

11           WHEREAS, In his capacity as executive director of the Paso  
12 Del Norte Children's Development Center, Mr. Barceleau oversees an  
13 organization whose mission is to provide therapeutic, educational,  
14 and day-care services to children with special needs; the center  
15 employs a staff of nearly 100, including doctors, rehabilitation  
16 therapists, and other health care professionals, and serves  
17 thousands of individuals every year; and

18           WHEREAS, A strong advocate of initiatives to improve the  
19 health and welfare of his city, Mr. Barceleau has also contributed  
20 significant time and energy to the successful campaign to build the  
21 El Paso Children's Hospital, which opens in 2012; in addition, he  
22 played an instrumental role in establishing the Border Children's  
23 Mental Health Collaborative, a county department that provides  
24 mental health care and counseling to children with mental and

1 emotional disturbances, and he has served on the boards of a number  
2 of worthy organizations, among them Goodwill Industries and the  
3 Northwest Community Health Center; and

4 WHEREAS, Through his caring, committed, and dynamic  
5 leadership, Jaime Barceleau has contributed immeasurably to  
6 strengthening the health and human service resources of El Paso,  
7 and he is indeed deserving of this prestigious honor; now,  
8 therefore, be it

10 Legislature hereby congratulate Jaime Barceleau on receiving the  
11 2011 Lifetime Achievement Award from the Rio Grande Branch of the
