11 education from Northwestern State University in Natchitoches,

15 Converse High School in Converse, Louisiana, in 1978, and in 1987 he

16 was appointed superintendent of High Island ISD; over the ensuing

18 and McKinney school districts, and in 2004 he was named

19 superintendent of Cypress-Fairbanks ISD, the third-largest school

20 district in Texas; in this role he has been responsible for more

21 than 106,000 students and 83 campuses and special program

22 facilities; under his leadership, the district received its third

23 consecutive Recognized rating from the Texas Education Agency in

24 2010, with 97 percent of the individual schools rated as either

- 7 the Cypress Fairbanks Medical Center and serves on the board of the

- 10 has led the way in fostering a supportive and challenging
- 11 educational environment in the Cy-Fair school district, and his
- 12 hard work and dedication have benefited many area schoolchildren;
