6 Missouri, on September 21, 1912; he graduated from Eldon High

7 School in 1931 and attended the University of Missouri until he was

8 commissioned as a second lieutenant through the ROTC; during World

9 War II, he served his country in the Pacific theater as a major in

10 the United States Army Air Corps; his decorations included an Army

11 Commendation Medal and Philippine Liberation Medal with a bronze

12 star; and

WHEREAS, Mr. Shepherd began working as a geophysicist for the

14 Continental Oil Company before the war; over the course of a long

15 and distinguished career, he served the corporation in numerous

16 capacities, accepting lengthy postings to Africa and the Middle

17 East and serving as manager of Conoco Central Region and president

18 of Sahara Petroleum Services Company in Alexandria, Egypt, among

19 other key positions; he retired from Conoco in 1976 as president of

20 Dubai Petroleum Company in the United Arab Emirates; moreover, he

21 served as president of the Oklahoma Petroleum Council and as an

22 advisor to the governor of Oklahoma; and

WHEREAS, A devoted husband, Mr. Shepherd shared a rewarding

- WHEREAS, In his retirement, Mr. Shepherd moved to Lakeway to
- 5 enjoy time with his loved ones and play golf; he was dedicated to
- 6 the community and helped guide it through a period of rapid growth
- 7 and development as mayor for two terms, from 1983-1987 and
- 8 1990-1991; his diplomatic yet decisive approach eased its
- 9 transition from a village to a city; in addition, he served as
- 10 president of Lakeway Civic Corporation and was a member of Chi
- 11 Epsilon Fraternity and a 32nd degree Scottish Rite Mason, and he
- 12 contributed generously to the construction of the narthex of
- 13 Lakeway Church; and
- 14 WHEREAS, The University of Missouri granted Mr. Shepherd his
- 15 bachelor's degree in civil engineering when he was 95; dignitaries
- 16 from his alma mater attended the graduation ceremony at his home,
- 17 along with many friends and relatives; and
- 18 WHEREAS, Ken Shepherd led a life rich with accomplishment,
- 19 and his dedication to Lakeway made a lasting, positive difference;
