- 6 School District Board of Trustees; her many professional and civic
- 7 contributions have earned her such titles as Hillsboro Chamber of
- 8 Commerce Citizen of the Year and SCLRT Community Librarian of the

- 11 with greater access to information, Susan Mann has been an
