Garza of Kingsville, who passed away on 3 March 13, 2011, at the age of 86, was indeed one such person; and 4 5 WHEREAS, A dedicated educator, administrator, and civic leader, Mrs. Garza was born in Kingsville on July 1, 1924, to 6 Antonia Saenz Alvarez and Adan Alvarez, Sr.; she earned her 7 master's 8 bachelor's and degrees from Texas A&MUniversity--Kingsville and began her notable career in 9 teaching first and third grades in Kingsville public schools; and 10 11 WHEREAS, In 1952, Mrs. Garza relocated to Corpus Christi, 12 where she continued teaching elementary students for nearly two decades; admired for her leadership, she served as Title VII 13 14 consultant for the district and as parent involvement coordinator at Lozano Elementary School; and 15 WHEREAS, Mrs. Garza left the classroom after nearly three 16 decades to become principal of Kennedy Elementary School in the 17 West Oso Independent School District in 1972; she went on to direct 18
- Harvey Elementary School in Kingsville ISD in the same capacity
 from 1979 until her retirement in 1986; and
 WHEREAS, A leader in her profession, Mrs. Garza helped to
 develop curriculum for the West Oso district and served on textbook

subcommittees for the state; she shared her time with the Texas

- 1 Association of School Administrators, National Education
- 2 Association, Texas State Teachers Association, and Kingsville
- 3 Tri-City Retired Teachers Association, which she served as

- 5 WHEREAS, Equally impressive was her involvement in a number
- 6 of worthwhile community organizations; she was active with the
- 7 boards of the Kingsville Symphony Orchestra, Music Club of
- 8 Kingsville, Lions Club, and Friends of the Conner Museum; in
- 9 addition, she chaired the board of the FLAIR Department of the
- 10 Woman's Club of Kingsville and worked with the City of Kingsville
- 11 Historical Development Board; while in Corpus Christi, her efforts
- 12 benefited the Symphony Guild and the Beautification Committee; and
- WHEREAS, Though it is impossible to gauge the full effect of a
- 14 person's life, some individuals leave their unmistakable mark on
- 15 the world as they move through it, and Aurora Garza's contributions
- 16 to her community will long resonate in the lives of all who knew
- 17 her; now, therefore, be it

- 19 Legislature hereby pay tribute to the memory of Aurora A. Garza and
- 20 extend deepest sympathy to the members of her family: to her sister,
