- 1 WHEREAS, A life filled with notable accomplishments drew to a
- 2 close when the Honorable Hiram Childress of Temple passed away on
- 3 February 10, 2011, at the age of 94; and
- 4 WHEREAS, Hiram Childress was born in Sweetwater on September
- 5 10, 1916, to Dan and Eula Mae Childress; after graduating from
- 6 Eastland High School, he attended Southern Methodist University,
- 7 where he earned a bachelor of laws degree in 1940; and
- 8 WHEREAS, Answering his nation's call to duty during World War
- 9 II, Mr. Childress joined the U.S. Army in 1942; assigned to the Army
- 10 Air Corps, he attained the rank of captain and served as an
- 11 intelligence officer in Britain, where he helped plan Allied
- 12 bombing missions against Germany; after the war, he continued to
- 13 serve his country with the U.S. Air Force Reserve until 1957, when
- 14 he was honorably discharged with the rank of major; and
- WHEREAS, Mr. Childress returned to Sweetwater at the end of
- 16 the war to open a law practice; drawn to public service, he soon ran
- 17 for a seat in the Texas House of Representatives, where he served
- 18 for two terms, from 1949 to 1953; during that time, he chaired the
- 19 Committee on Conservation and Reclamation and served on the Water
- 20 Code and Criminal Jurisprudence Committees, among others; and
- 21 WHEREAS, Following his retirement from the legislature, Mr.
- 22 Childress opened a law office in Temple; he later relocated to
- 23 Washington, D.C., to work with the U.S. Department of Agriculture;

- 1 WHEREAS, Hiram Childress and his wife, the former Juanita
- 2 Bush, were joined in matrimony on January 10, 1965, and enjoyed a
- 3 rewarding 46 years together; shortly after their marriage, he
- 4 retired from the agriculture department and moved back to Temple to
- 5 resume his law practice; and
- 6 WHEREAS, This esteemed Texan was a valued congregant of
- 7 Avenue T Church of Christ in Temple, and he was affiliated with Elks
- 8 lodges in both Temple and Sweetwater; he was also a Master Mason and
- 9 a member of Shriners International; and
- 10 WHEREAS, A distinguished member of the State Bar of Texas for
- 11 71 years, Hiram Childress built a successful career in both the
- 12 public and private sectors, and he leaves behind a record of service
- 13 that his loved ones can indeed remember with pride; now, therefore,
