- 6 she was named salutatorian of her class at Booker T. Washington
- 7 School and graduated from Centerpoint High School in Pittsburg;
- 8 determined to further her education, she went on to attend Prairie
- 9 View State Normal and Industrial College; and
- 10 WHEREAS, She married United States Army Corporal Maceo
- 11 Trammell on January 17, 1942, and the couple shared a rewarding
- 12 relationship of 36 years before his passing in 1978; kind and
- 13 nurturing, Mrs. Trammell dedicated herself to the well-being of her
- 14 nieces and nephews and has been an outstanding role model for her
- 15 younger relatives; and
- 16 WHEREAS, Through the years, she worked as a seamstress and
- 17 debt collector and cared for a number of children in their homes;
- 18 Mrs. Trammell has most notably benefited Mt. Olive Baptist Church,
- 19 where she is a lifelong member and has run the kitchen and served as
- 20 superintendent of the Sunday school; taking on myriad leadership
- 21 roles, she has served as commander and secretary of the American
- 22 Woodmen and as secretary of the Heroines of Jericho; in addition,
- 23 she has been a member of the Ladies' Sunshine Club and the Secret

- 6 Wheels route; moreover, she gave generously of her time and talents
- 7 to assist "the old folks" in nursing homes, sewing and laundering
- 8 gowns for them and bringing cheer through her vivacious
- 9 personality; and
- 10 WHEREAS, Mrs. Trammell has spent many happy hours socializing
- 11 over pinochle and a variety of board and card games; blessed with
- 12 numerous talents, she has earned great admiration for her beautiful
- 13 quilts and adventurous cooking, and her delicious hot tamales, made
- 14 from scratch, have always been much in demand; and
- WHEREAS, Vibrant and generous, Hazel Trammell is a source of
- 16 inspiration to all who are fortunate enough to know her, and she may
- 17 reflect with satisfaction on a century of life well lived; now,
