- 8 later and worked as a legal assistant and office manager at several
- 9 prominent law firms; and
- 10 WHEREAS, Intent on becoming an attorney herself,
- 11 Ms. Purham-Brown relocated to Atlanta, where she earned a doctor of
- 12 jurisprudence degree from the Atlanta Law School in 1991; she was
- 13 admitted to the Georgia State Bar that same year and later to the
- 14 United States District Court for the Northern District of Georgia;
- 15 after returning to Houston, she was admitted to practice before the
- 16 U.S. District Court for the Southern District of Texas and
- 17 cofounded Brown, Brown & Reynolds, one of the largest and most
- 18 successful minority-owned law firms in the state; as one of the
- 19 firm's three name partners, she worked alongside her husband,
- 20 Conrell Brown, and her son, Ron Reynolds, and focused her practice
- 21 on social security disability; and
- WHEREAS, Ms. Purham-Brown served her professional community
- 23 as a member of the Gate City Bar Association, the National Bar
- 24 Association, the National Organization of Social Security Claims

- 1 Representatives, the American Bar Association, and the Houston
- 2 Lawyers Association; moreover, she was an active member of the Beta
- 3 Epsilon Omega Chapter of Alpha Kappa Alpha, a service organization
- 4 that encourages the empowerment of women and advocates for basic
- 5 human rights; and
- 6 WHEREAS, In her free time, Ms. Purham-Brown found pleasure in
- 7 gourmet cooking and hosting gatherings of her family, which, in
- 8 addition to her husband and her son Ron, included her son Chris, her
- 9 daughter-in-law, Jonita, and her granddaughter, Lacey; a woman of
- 10 deep faith, she also drew support from her fellow congregants at
- 11 Brookhollow Baptist Church and found great joy in helping others;

- WHEREAS, Glenda Purham-Brown was a woman of strength and
- 14 compassion whose belief in overcoming injustice through faith,
- 15 education, and determination will long inspire all those who had
- 16 the good fortune to share in her life; now, therefore, be it
