## RESOLUTION

- 1 WHEREAS, For his outstanding dedication to classical music in
- 2 the Rio Grande Valley, Dr. Carl Seale is being honored at the Valley
- 3 Symphony Orchestra and Chorale Red Bow Concerto Gala on April 30,
- 4 2011; and
- 5 WHEREAS, Dr. Seale holds a bachelor's degree in music from
- 6 Baylor University, a master's degree in music from the University
- 7 of Louisville, and a doctor of musical arts degree in composition
- 8 from the University of North Texas; he worked as the orchestra
- 9 director for high schools in Denton and Edinburg before serving as
- 10 the head band director at Harlingen High School for six years; in
- 11 1971, he joined the faculty of The University of Texas--Pan
- 12 American and two years later was appointed conductor of the Valley
- 13 Symphony Orchestra; and
- 14 WHEREAS, The sixth person to fill this prestigious position
- 15 since the orchestra was founded in 1952, Dr. Seale helped to ensure
- 16 the group's ongoing success by leading the effort to form the South
- 17 Texas Symphony Association, which was organized in 1976 to
- 18 supplement UT--Pan American in its support of the orchestra; also
- 19 during Dr. Seale's tenure, the Rio Grande Valley Chorale joined the
- 20 VSO, becoming a permanent addition to the concert season; and
- 21 WHEREAS, A gifted and prolific composer, Dr. Seale has
- 22 created works in a wide variety of genres, including two ballets,
- 23 two operas, and three series of hymn tunes, and his composition "The
- 24 Flight of Icarus" won the Texas Orchestra Directors Association

- 1 Composition Contest in 1996; he conducted his own "Symphony for
- 2 Friends: A Farewell" in May 2001 to mark his retirement from the
- 3 orchestra, and later that year, he fulfilled a commission by the
- 4 Valley Land Fund with a multimedia piece he named "Jewels of a Land
- 5 Alive"; and
- 6 WHEREAS, Dr. Seale has further distinguished himself as a
- 7 quest conductor with the San Antonio Symphony Orchestra and several
- 8 Mexican state orchestras, as a clinician and conductor for school
- 9 bands in Texas, Kentucky, and Indiana, and as the longtime music
- 10 director for the First Presbyterian Church in McAllen, where he
- 11 composed and arranged a number of works for the choir; although he
- 12 is now retired, he continues to serve as conductor emeritus of the
- 13 Valley Symphony Orchestra and Chorale and as professor emeritus at
- 14 UT--Pan American; and
- WHEREAS, Dr. Carl Seale's musical achievements have inspired
- 16 and delighted audiences in the Rio Grande Valley for more than 30
- 17 years, and he may indeed take great pride in his contributions to
- 18 the cultural richness of the region; now, therefore, be it
- 19 RESOLVED, That the House of Representatives of the 82nd Texas
- 20 Legislature hereby pay tribute to Dr. Carl Seale on the occasion of
- 21 the Valley Symphony Orchestra and Chorale Red Bow Concerto Gala
- 22 2011 and extend to him sincere best wishes for continued happiness;
