2 of John Edwin Horn of Lorena, who passed away on March 27, 2011, at  
3 the age of 76; and

4           WHEREAS, Born in Greenville, Kentucky, on Christmas Day,  
5 1934, to Wilty and Ruby Horn, John Horn was the fourth of 13  
6 children; he served his country in the United States Army from 1953  
7 to 1956, and then hitchhiked to Chicago, joining four of his

17 he especially loved attending their many extracurricular  
18 activities, from football games to dance performances; he also  
19 enjoyed traveling and playing cards and dominoes with his family  
20 and friends; in addition, he was a valued member of the Brazos  
21 Meadows Baptist Church for more than two decades; and

22           WHEREAS, John Horn lived a full and generous life surrounded  
23 by those he loved, and the memory of his delight in their company  
24 will long endure to comfort them; now, therefore, be it
