## RESOLUTION

1 WHEREAS, The late Ramiro Barrera, Sr., played a vital role as 2 an educator and community leader in Starr County for many decades, 3 and his life and legacy are indeed worthy of tribute; and WHEREAS, Ramiro Barrera was born in Los Saenz in 1920 to 4 Trinidad and Benilde Barrera, both of whom were descended from 5 founding families of the historic border village; his father was a 6 7 rancher and his mother ran a small neighborhood store, and together they instilled a strong work ethic in their children, who were all 8 expected to pitch in to help operate the family businesses; by the 9 time he was six, Ramiro would rise early in the morning and trek 10 11 several miles to carry breakfast to the herdsman watching over his 12 father's goats; he would then return home with milk for his family; it was on these daily journeys that he began to develop his 13 14 appreciation for the native flora and fauna of the Texas-Mexico border region; and 15 WHEREAS, An avid student, Mr. Barrera attended Los Saenz 16 Elementary for four years, after which he went to Roma Elementary; 17 he then progressed to Roma High School, where he was taught by the 18 Sisters of Mercy, who imparted to him a love for literature and 19 20 learning and helped him to develop discipline through their firm 21 but kind methods; because Roma High School only offered instruction through the 11th grade, he continued his education at Rio Grande 22 23 High School in Rio Grande City, graduating with honors in 1937; and 24 WHEREAS, Determined to pursue his dream of obtaining a

- 1 college education, even though the country was still mired in the
- 2 Great Depression and money was scarce, Mr. Barrera enrolled at the
- 3 Texas College of Arts and Industries in Kingsville; to help pay for
- 4 tuition, he began teaching elementary school in Garceno, and he
- 5 went on to teach at schools in Fronton and Chapeno; and
- 6 WHEREAS, Mr. Barrera's studies were interrupted by the
- 7 outbreak of World War II; answering his nation's call to duty, he
- 8 joined the U.S. Army in 1941; during his four years in the military
- 9 he served in England, Scotland, France, and on special assignment
- 10 in Portugal; and
- 11 WHEREAS, After his discharge from the army in 1945,
- 12 Mr. Barrera returned to Kingsville to complete his degree with the
- 13 financial assistance of the GI Bill; during this time he met his
- 14 wife, the former Crescencia Izaquirre, and the couple were joined
- 15 in matrimony in May 1950; and
- 16 WHEREAS, In 1948, Mr. Barrera returned to Los Saenz
- 17 Elementary to serve as head teacher; he worked at the school for two
- 18 and a half years before accepting an offer to teach social studies
- 19 at San Isidro High School; during the summers he continued to pursue
- 20 his education at Southwest Texas State College in San Marcos, where
- 21 he earned a master's degree in education in 1954; he began his
- 22 career in education administration that same year, when he joined
- 23 the Roma Independent School District as a junior high principal;
- 24 the next year he became the principal of Roma High School, a
- 25 position he held for 22 years; during his tenure there, he helped
- 26 guide the school through a time of steady growth and success; and
- WHEREAS, Mr. Barrera retired as principal of Roma High School

- 1 in 1978, at the age of 58; he then joined the Southwest Educational
- 2 Development Laboratory as a part-time consultant and researcher,
- 3 working with several schools in Starr County; after four years with
- 4 SEDL, he retired from education for good in order to spend time with
- 5 his wife and family and to focus on his ranches in Starr and Zapata
- 6 Counties; he remained in touch with former colleagues through his
- 7 involvement with the Roma Retired Teachers Association; and
- 8 WHEREAS, A respected member of his community, Mr. Barrera was
- 9 active in Our Lady of Refuge Church in Roma, and he volunteered his
- 10 time with a number of organizations devoted to helping others;
- 11 moreover, he was a member of the Veterans of Foreign Wars and the
- 12 Knights of Columbus, holding third-degree Knight status with the
- 13 Roma chapter and fourth-degree Knight status with the Rio Grande
- 14 City chapter; he also worked with the Starr County Historical
- 15 Society to preserve the history of the area, and he provided
- 16 valuable assistance with researching the early days of Roma and Los
- 17 Saenz and the communities' founding families; and
- WHEREAS, Mr. Barrera further dedicated himself to preserving
- 19 the environment and natural resources of the area; his efforts were
- 20 recognized by the Rio Bravo Resource Conservation District, which
- 21 honored him with its Distinguished Service Award for 17 years of
- 22 service, and by the Starr County Soil and Water Conservation
- 23 District, which presented him with an award for 22 years of service;
- 24 and
- 25 WHEREAS, During his nearly 40 years in the field of
- 26 education, Mr. Barrera had a significant impact on the lives of
- 27 countless young people, and he had the great pleasure of seeing many

- 1 of his students grow up to enjoy successful and productive lives; on
- 2 March 29, 2007, the Roma Independent School District named its
- 3 newest campus the Ramiro Barrera Middle School, in honor of his
- 4 exceptional service as a teacher and an administrator; and
- 5 WHEREAS, Although Ramiro Barrera, Sr., passed away in 2004,
- 6 his memory lives on in his children, Annabel Pena and Dr. Ramiro
- 7 Barrera, Jr., and in his five grandchildren, Daniel Barrera, Angela
- 8 Barrera, Aaron Pena, Adrian Pena, and Ariel Pena; they inherited
- 9 from him the same dedication to education, conservation, and
- 10 community service that made him a role model to many of his former
- 11 students and colleagues; and
- WHEREAS, Deeply devoted to his family and community, Ramiro
- 13 Barrera, Sr., made a meaningful difference in the lives of his loved
- 14 ones and fellow citizens alike, and his contributions will be
- 15 fondly remembered for years to come; now, therefore, be it
- RESOLVED, That the House of Representatives of the 82nd Texas
- 17 Legislature hereby honor the memory of Ramiro Barrera, Sr., for his
- 18 extensive public service; and, be it further
- 19 RESOLVED, That an official copy of this resolution be
- 20 prepared for his family and that when the Texas House of
- 21 Representatives adjourns this day, it do so in memory of Ramiro
- 22 Barrera, Sr.
