1 WHEREAS, A full and generous life drew to a close with the 2 passing of Betty Ruth Ritterhoff Armstrong of Waco on April 3, 2011, 3 at the age of 92; and

WHEREAS, Born in Chicago on October 10, 1918, the former Betty Ritterhoff was the daughter of Henry and Edith Ritterhoff; she attended schools in New York and Chicago, where she met her future husband, Edward LaVerne Armstrong; the couple married in Wollaston, Massachusetts, on August 31, 1940, and later became the parents of two children, James and Richard; they moved to Weatherford in 1951; and

11 WHEREAS, Mrs. Armstrong was employed for 30 years as 12 secretary of Grace First Presbyterian Church, where she became an 13 ordained elder; she served as president of Presbyterian Women and 14 was presented with a life membership; in addition, she led Circle 15 Bible Studies, taught Sunday school, and visited the homebound and 16 residents of nursing homes; and

WHEREAS, Deeply committed to her community, Mrs. Armstrong was a member and officer of the PTA and chaired the committee that developed a public library for children; later, she helped organize the Friends of the Weatherford Library and served as membership chair; she became one of the first volunteers for Meals on Wheels, serving a regular weekly route for many years; and

23 WHEREAS, In the early 1980s, Mrs. Armstrong played a key role 24 in the establishment of Manna Storehouse, Inc., a nonprofit food

1 pantry and supply house; she was a strong advocate and active 2 volunteer for the organization, assisting clients and serving the 3 board as corresponding secretary; in her nineties she moved to Waco 4 and continued to volunteer in the community as her health 5 permitted; and

6 WHEREAS, The numerous accolades granted Mrs. Armstrong 7 include the 1998 Governor's Volunteer Award; she was recognized as 8 one of President George H. W. Bush's "Thousand Points of Light" and 9 was named Outstanding Woman of the Southwest by the Presbyterian 10 Women of Grace First Presbyterian; and

11 WHEREAS, Mrs. Armstrong enjoyed traveling with her husband in 12 their retirement years and camping and fishing both in Texas and 13 around the country; she was gifted at needlework and even more 14 talented in crocheting afghans; and

15 WHEREAS, Betty Armstrong expressed her faith by helping 16 others with tireless dedication, and she made a lasting, positive 17 difference in her community; although she will be deeply missed by 18 those she leaves behind, they will forever remember her kindness 19 and devotion; now, therefore, be it
