- 16 service in the military, he hoped to make the army a career; and
- 17 WHEREAS, Among the many awards conferred on Staff Sergeant
- 18 Benitez were the Bronze Star, the Purple Heart, and the Good Conduct
- 19 Medal, as well as the National Defense Service Medal, the
- 20 Afghanistan Campaign Medal with a bronze star, the Iraq Campaign
- 21 Medal with four bronze stars, and the Global War on Terrorism
- 22 Service Medal; and
- 23 WHEREAS, Carlos Benitez was the loving husband of Susana
- 24 Benitez, whom he wed on January 11, 2008, and the devoted father of
