22 family, and she looked forward to summer family reunions in
23 Arkansas and the chance to visit with her cousins and other Madding

2 others were of tremendous value to all who had the good fortune to
3 know her, and memories of this beloved woman will forever endure in
4 their hearts; now, therefore, be it
