- 2 devoted community leader with the passing of Thomas Patton
- 3 Alexander, Sr., on September 26, 2010, at the age of 83; and
- WHEREAS, Tom Alexander was born in Galveston on December 29,
- 5 1926, to Charles Hansborough and Helen Drysdale Alexander; he
- 6 attended Alvin schools before serving in the U.S. Merchant Marine
- 7 from 1944 to 1946; he later studied at Shriner Institute, Texas A&M
- 8 University, and Baylor University; and
- 9 WHEREAS, Settling in Pearland in 1949, Mr. Alexander began a
- 10 long and successful career in business, working in real estate, the
- 11 petroleum industry, and rice farming; he helped to develop the
- 12 Golfcrest Country Club and the city's Nottingham and Alexander
- 13 Landing neighborhoods; and
- 14 WHEREAS, This esteemed gentleman further contributed to the
- 15 area as a signer of the city's charter in the 1950s and as an
- 16 original member of the Pearland City Council and the Pearland
- 17 Volunteer Fire Department; in addition, his leadership benefited
- 18 the Pearland Chamber of Commerce, the Golfcrest Country Club, the
- 19 Pearland YMCA, and the Pearland State Bank, which he served as a
- 20 board member for 40 years; and
- 21 WHEREAS, In his leisure time, Mr. Alexander was an avid
- 22 baseball fan who supported the Pearland Little League and followed
- 23 the fortunes of the Houston Astros; and
- 24 WHEREAS, Mr. Alexander enjoyed the love and support of his

- 1 wife, the former Bettye Garrett Mathis, whom he married in the late
- 2 1940s; together they shared a fulfilling marriage and were blessed
- 3 with four children, Harriett, Cynthia, Diana, and Thomas, as well
- 4 as seven grandchildren and seven great-grandchildren; Mr.
- 5 Alexander was a member of Pearland Methodist Church; and
- 6 WHEREAS, Tom Alexander dedicated his life to the betterment
- 7 of Pearland, and he will forever be remembered for his outstanding
- 8 efforts in behalf of his fellow residents; now, therefore, be it
