Slider Middle School, and finally at Myrtle Cooper Elementary; and 13 14 WHEREAS, Affectionately known as "Poncho," "Mr. C.," and "El Jefe" (the Boss), Mr. Cardenas held dear a wide circle of friends, 15 16 and his home was the scene of many fondly remembered gatherings; those lively occasions included the annual, highly anticipated 17 "three-campus reunion, cookout, and swim party," which brought 18 together staff and faculty from each school where he served as 19 20 principal; in addition to the esteem he enjoyed as a result of his 21 work in the SISD, Mr. Cardenas won deep affection and appreciation for his volunteer efforts as a Little League umpire, youth 22 basketball referee, and cofounder of the Golden Gloves at San Juan 23 24 Community Center; his role in establishing the latter program won
