6 siblings; she attended Pan American University and graduated from
7 The University of Texas at Austin; and

9 broker's license in 2006, the same year she retired from a
10 quarter-century of employment with the State of Texas; and

11 WHEREAS, Possessed of a warm and generous spirit, Terrie
12 Rabago nurtured her relationships with her loved ones, helped
13 newcomers become connected to life in the Capitol City, and
14 generously welcomed others into her Austin home, the site of much
15 socializing and community-project strategizing over the years; and

16 WHEREAS, A graduate of Leadership Texas, Ms. Rabago shared
17 her talents with a host of community organizations and worthy
18 causes; she sat on the boards of the Hispanic Women's Network of
19 Texas, the Austin History Center, CASA (Court Appointed Special
20 Advocate Association), and TEACH Quest, served as president of the
21 Austin chapter of the Hispanic Women's Network, and held a seat on
22 Austin's Historic Landmark and Zoning and Platting Commissions, in
23 addition to maintaining an affiliation with numerous other groups;
