1 WHEREAS, June 11, 2011, marks the 50th wedding anniversary of
2 David and Caroline Pierce of Houston, and this joyous event
3 provides a fitting opportunity to reflect on their memorable
4 journey together as husband and wife; and

5 WHEREAS, David Pierce and the former Caroline Ridling met in
6 1959 as seniors at the University of Oklahoma; immediately after
7 their graduation in 1961, they were joined in matrimony at a
8 ceremony held in the bride's hometown of Ada, Oklahoma; through the
9 years, the couple have been blessed with a treasured family that
10 includes two sons and daughters-in-law, David and Annie and Robert
11 and Amy, and six grandchildren, Ellery, Luc, Kendall, Kyle,
12 Kaitlyn, and Kamren; and

13 WHEREAS, Mr. Pierce grew up in Velma, Oklahoma, and he played
