

R E S O L U T I O N

1 WHEREAS, Neeta Sane, a distinguished member of the Houston
2 Community College Board of Trustees, has provided exemplary service
3 both to the school and to the people of Fort Bend County; and

4 WHEREAS, Elected to the HCC Board of Trustees in 2007, Ms.
5 Sane has worked tirelessly to strengthen the college's capacity to
6 serve as a pathway to higher education and workforce training; in
7 2008, she played an instrumental role in bringing Alief into the HCC
8 system, and she has promoted the building of business partnerships
9 to advance the school's mission; in recent months, she has launched
10 a series of regional workforce summits to explore new ways in which
11 HCC can address local workforce needs, and one result has been the
12 establishment of a new AAS degree program in logistics and global
13 supply chain management; Ms. Sane has also focused on developing
14 outreach to low-income and underserved communities, on improving
15 support services for minority and economically disadvantaged
16 students, and on instituting a diversity program for the benefit of
17 students and staff; while chair of the trustees' Athletics
18 Committee, she oversaw the inauguration of yet another resource for
19 the student body, a system-wide intramural program; and

20 WHEREAS, Born in Bombay, India, Ms. Sane holds an M.S. from
21 the University of Bombay and another master's degree from the
22 University of Houston--Clear Lake; in addition to serving on the
23 HCC Board of Trustees, she manages a Stafford-based software
24 development and consulting firm, which she established in 2001;

1 this successful entrepreneur has been an active member of the
2 Rotary Club of Sugar Land and the League of Women Voters, and she
3 has held leadership positions in a number of community
4 organizations, among them the American Association of University
5 Women and the Fort Bend Democratic Party; she currently serves as
6 vice president of the National Diversity Council, and she was the
7 driving force behind the establishment of the annual International
8 Festival of Fort Bend County; and

9 WHEREAS, Determined to make quality education accessible and
10 affordable for her fellow citizens and to help build a prosperous
11 and inclusive community, Neeta Sane is indeed making a positive
12 difference in the lives of countless Texas residents; now,
13 therefore, be it

14 RESOLVED, That the House of Representatives of the 82nd Texas
15 Legislature hereby honor Neeta Sane for her outstanding
16 contributions in behalf of Houston Community College and the people
17 of Fort Bend County; and, be it further

18 RESOLVED, That an official copy of this resolution be
19 prepared for Ms. Sane as an expression of high regard by the Texas
20 House of Representatives.
