RESOLUTION

- 1 WHEREAS, Jay T. Kimbrough rendered exemplary service to this
- 2 country as a member of the United States Marine Corps during the
- 3 Vietnam War, and in honor of the 3,416 Texans who died in that
- 4 conflict, he is leading a ceremonial procession down Congress
- 5 Avenue in Austin on October 15, 2011; and
- 6 WHEREAS, Born in Dallas in 1947, Jay Kimbrough grew up in the
- 7 South Oak Cliff area; he accumulated enough credits to graduate
- 8 from high school a semester early and enlisted in the Marine Corps
- 9 in January 1966; after completing boot camp in San Diego, he arrived
- 10 in Vietnam in August 1966 and was assigned to Company A, 1st
- 11 Battalion, 3rd Marines; and
- WHEREAS, On May 10, 1967, during Operation UNION 1, Lance
- 13 Corporal Kimbrough's platoon was sent to reinforce members of the
- 14 5th Marines who were heavily engaged with a large force of Viet Cong
- and North Vietnamese Army troops; the helicopter Corporal Kimbrough
- 16 was riding in was shot down, and he was severely wounded; he and his
- 17 fellow survivors remained under intense small arms and automatic
- 18 weapons fire and were unable to move; and
- 19 WHEREAS, The platoon sergeant, Jimmie L. West, determined the
- 20 location of the helicopter and moved out through heavy enemy fire
- 21 until he reached Corporal Kimbrough and the other survivors;
- 22 Sergeant West then covered them on the way back, delivering
- 23 suppressive fire as he brought them to safety; and
- 24 WHEREAS, Corporal Kimbrough was flown to the hospital ship,

- 1 USS Sanctuary, for treatment, while Operation UNION 1 continued; on
- 2 May 12, Company D, 1st Battalion, 5th Marines engaged a huge North
- 3 Vietnamese Army force and suffered high casualties, including
- 4 Cloyde Pinson, Jr., one of Jay Kimbrough's closest friends from
- 5 Dallas; and
- 6 WHEREAS, Corporal Kimbrough was medically evacuated to the
- 7 Corpus Christi Naval Air Station Hospital and was a patient there
- 8 for his remaining eight months in service; and
- 9 WHEREAS, Among the decorations conferred on Mr. Kimbrough are
- 10 the National Defense Service Medal, the Vietnam Service Medal, the
- 11 Vietnam Campaign Medal, two Presidential Unit Citations, the
- 12 Vietnam Gallantry Cross Unit Citation, the Purple Heart, and the
- 13 Rifle Sharpshooter; and
- WHEREAS, Discharged from the Marine Corps on February 23,
- 15 1968, Corporal Kimbrough returned to his hometown, where he
- 16 attended Southern Methodist University with the help of the GI
- 17 Bill; after graduating with a bachelor's degree in business
- 18 administration, he earned a juris doctorate from South Texas
- 19 College of Law; he subsequently served in the United States Navy
- 20 Judge Advocate General's Corps from 1978 to 1984, attaining the
- 21 rank of lieutenant commander; he has since continued his dedication
- 22 to public service through his notable work for the State of Texas;
- 23 and
- 24 WHEREAS, Jay Kimbrough, like many Vietnam War veterans, met
- 25 with resistance and ingratitude for his military service after
- 26 returning to the United States; he has devoted much of his life to
- 27 ensuring that the courage and patriotism of his friend Cloyde

- 1 Pinson and the many other fallen Texas heroes are not forgotten by
- 2 future generations; now, therefore, be it
- RESOLVED, That the House of Representatives of the 82nd Texas
- 4 Legislature hereby honor Jay T. Kimbrough for his distinguished
- 5 military service and commend him for his ongoing efforts to
- 6 commemorate those Texans who made the ultimate sacrifice in
- 7 Vietnam; and, be it further
- 8 RESOLVED, That Mr. Kimbrough be presented with the flags
- 9 flown over the Texas Capitol on October 15, 2011, as an expression
- 10 of high regard by the Texas House of Representatives.
