- 5 of 12, Dr. Bertheau graduated from the University of Pennsylvania
- 6 School of Medicine and completed his internship at Hennepin County
- 7 Medical Center in Minneapolis in 1965; he became a diplomate of the
- 8 Board of Medical Examiners the following year and subsequently
- 9 joined the Public Health Service, a branch of the United States
- 10 Navy, which sent him to Fort Worth; and
- 11 WHEREAS, Dr. Bertheau later set up a successful family
- 12 medical practice in Lake Jackson, earning a reputation as a caring
- 13 and compassionate physician who truly listened to and made time for
- 14 his patients and who had an excellent knowledge of medicine;
- 15 admired by his colleagues and his community, he served as president
- 16 of the Brazoria County Medical Society as well as Doctor of the Day
- 17 for the Texas Legislature on several occasions; and
- 18 WHEREAS, With a deep commitment to alleviating human
- 19 suffering, he became one of the first doctors to volunteer his
- 20 services at a local community nonprofit providing health care to
- 21 the uninsured; he also supported efforts to obtain medical supplies
- 22 for mission trips to Mexico and Africa through his church and the
- 23 Lake Jackson Rotary Club; and
- 24 WHEREAS, In all his endeavors, Dr. Bertheau was noted for his
