- BE IT RESOLVED by the House of Representatives of the State of
- 2 Texas, 82nd Legislature, Regular Session, 2011, That House Rule 13,
- 3 Section 9(a), be suspended in part as provided by House Rule 13,
- 4 Section 9(f), to enable the conference committee appointed to
- 5 resolve the differences on House Bill 2499 (continuation and
- 6 functions of the Department of Information Resources and the
- 7 transfer of certain department functions to the comptroller of
- 8 public accounts), to consider and take action on the following
- 9 matter:
- House Rule 13, Section 9(a)(4), is suspended to permit the
- 11 committee to add text on a matter which is not included in either
- 12 the house or senate version of the bill by adding the following
- 13 sections to the bill:
- 14 SECTION 25. Subchapter A, Chapter 2157, Government Code, is
- amended by adding Section 2157.0013 to read as follows:
- Sec. 2157.0013. SUNSET PROVISION. (a) The transfer of
- 17 powers and duties to the comptroller under Section 2157.068 and
- 18 under House Bill 2499, Acts of the 82nd Legislature, Regular
- 19 Session, 2011, is subject to Chapter 325 (Texas Sunset Act).
- 20 <u>(b) The Sunset Advisory Commission shall evaluate the</u>
- 21 transfer of powers and duties to the comptroller under Section
- 22 2157.068 and under House Bill 2499, Acts of the 82nd Legislature,
- 23 Regular Session, 2011, and present to the 84th Legislature a report
- 24 on its evaluation and recommendations in relation to the transfer.

- 1 The comptroller shall perform all duties in relation to the
- 2 evaluation that a state agency subject to review under Chapter 325
- 3 would perform in relation to a review.
- 4 (c) This section expires September 1, 2015.
- 5 SECTION 39. (a) The comptroller shall submit, on the dates
- 6 prescribed by Subsection (c) of this section, a report regarding
- 7 the transfer described by Section 37 of this Act to the following:
- 8 (1) the Legislative Budget Board;
- 9 (2) the speaker of the house of representatives;
- 10 (3) the lieutenant governor; and
- 11 (4) the chairs of the house and senate committees with
- 12 primary oversight over the comptroller's purchasing functions.
- 13 (b) The report must analyze the efficiency and
- 14 implementation of the transfer described by Section 37 of this Act.
- 15 (c) Each report described by this section is due not later
- 16 than:
- 17 (1) March 1, 2012;
- 18 (2) September 1, 2012;
- 19 (3) September 1, 2013; and
- 20 (4) September 1, 2014.
- 21 Explanation: This change is necessary to require sunset
- 22 review of, and a report on, the transfer of certain purchasing
- 23 functions to the comptroller.
