- 11 Springs Edwards Aquifer Conservation District as well as the

- 15 of nature; and
- WHEREAS, Dr. Butler earned his bachelor's and master's
- 17 degrees and his doctorate from the University of Wisconsin and came
- 18 to UT in 1978; in recent years, he secured more than \$3 million in
- 19 funding for environmental planning research and programs

- 21 endeavors, he enjoyed the love and support of his wife, Christy, and
- 22 he took pride in a fine family that includes four children, Lana,
- 23 Emily, Josh, and Nick; and
