6 WHEREAS, Bud Price was born in Kilgore on March 31, 1935, to

7 Donald Price, Sr., and Juanita Price; after graduating from Pine

8 Tree High School in Greggton in 1953, he attended Baylor

9 University, where he earned a bachelor's degree in business

10 administration in 1958; immediately after college, he answered his

11 nation's call to duty by enlisting in the U.S. Army, and he was

12 stationed in Munich, Germany, for most of his service; and

WHEREAS, Following his discharge from the military in 1960,

14 Mr. Price returned to East Texas and accepted a job as an accountant

15 in Longview; in 1962, he began his distinguished banking career

16 when he became a commissioned national bank examiner with the

17 Office of the Controller of the Currency, United States Treasury

18 Department; he served in that capacity in Longview and Dallas, and

19 he later led the Corpus Christi office; in 1966, he joined the

20 National City Bank of Waco, where he served as vice president and

21 senior president in charge of loans until 1979, when he became

22 director and president of Robinson State Bank; in 1988, he was hired

23 as director and president of Waco State Bank; and

24 WHEREAS, During his tenure with Waco State Bank, the

- 1 institution merged with Robinson State Bank to form Fidelity Bank
- 2 of Texas, which Mr. Price continued to serve as president and
- 3 director; he also served as chair of the board and as the chief
- 4 executive officer and president of its holding company, Fidelity
- 5 Bancshares, Inc.; at the time of his retirement, he had more than 42
- 6 years of experience in the banking industry; and
- 7 WHEREAS, This highly accomplished gentleman played an active
- 8 role in his community as well and he contributed his time to
- 9 numerous professional and civic organizations, including the Waco
- 10 Clearing House Association, the Texas Association of Business,
- 11 Downtown Waco, Inc., the Waco-McLennan County Library Board, the
- 12 Friends of the Library Board, the Freeman Center, the American Red
- 13 Cross, Rebuilding Together of Greater Waco, and the Texas Bankers
- 14 Association; he also shared his expertise with Lott State Bank and
- 15 Pakrite Plastics and on the advisory board of the Heart of Texas
- 16 Council of Governments and the Heart of Texas Region Mental Health
- 17 Mental Retardation Center; and
- WHEREAS, A former director and treasurer of the Texas Ranger
- 19 Hall of Fame and Museum, Mr. Price participated in a host of other
- 20 worthy groups such as several chambers of commerce, the Kiwanis
- 21 Club, the Baylor Alumni Association, Waco Masonic Lodge No. 92, and
- 22 the Masonic Knights Templar, Waco Commandry No. 10; and
- 23 WHEREAS, Despite his many professional and civic
- 24 commitments, Mr. Price made his family and faith his main
- 25 priorities in life; he enjoyed a rewarding marriage of 47 years with
- 26 his wife, the former Helen Hardy, whom he wed on August 31, 1963,
- 27 and he was the father of two sons, Craig and Bradley; he joined the

- 1 congregation of the First Baptist Church of Waco in 1966, and he
- 2 served on many church committees, and was ordained as a deacon in
- 3 1990; a president of the McCall Sunday school class, he was also a
- 4 seven-year member of the Bible Study Fellowship; and
- 5 WHEREAS, In his free time, Mr. Price carved pipes and made
- 6 tampers and collected unique tobacco tins and pipes, as well as
- 7 books, steins, canes, and knives; he enjoyed reading and classical
- 8 music, and his other hobbies included hunting, fishing, cooking,
- 9 bartering, crafting belt buckles, and playing "84" with family and
- 10 friends; and
- 11 WHEREAS, Bud Allan Price lived a rich and purposeful life,
- 12 and he will long be remembered with deep affection by all who were
- 13 privileged to know him; now, therefore, be it
