- 1 WHEREAS, Dennis Hart was instrumental in the passage of House
- 2 Bill 2038, requiring Texas schools to establish a protocol for
- 3 dealing with student-athletes suspected to have sustained a
- 4 concussion; and
- 5 WHEREAS, The legislation, which was authored by State
- 6 Representative Four Price, has been named "Natasha's Law" in honor
- 7 of Natasha Helmick, whose soccer career ended after she suffered
- 8 five concussions in four years; involved in the sport since age
- 9 four, she earned a scholarship to play for Texas State University,
- 10 but a medical evaluation changed the course of her path; and
- 11 WHEREAS, Mr. Hart's efforts in behalf of this bill included
- 12 testifying before the House Committee on Public Health, discussing
- 13 its importance with numerous members of the legislature and
- 14 attending a press conference at the Capitol shortly after the bill
- 15 was introduced in the house; and
- 16 WHEREAS, A longtime athletic trainer, Mr. Hart began his
- 17 career in 1970 and worked at North Mesquite High School from 1973
- 18 until his retirement in 2006; he went on to become the director for
- 19 clinical and outreach services for the Sports Medicine Clinic of
- 20 North Texas in Dallas and also returned to athletic training
- 21 part-time at a middle school in Mesquite; and
- WHEREAS, Mr. Hart has served as president of the Southwest
- 23 Athletic Trainers' Association and as chair of the founding
- 24 committee of the Texas State Athletic Trainers' Association; he has

- 1 received many recognitions at the district, state, and national
- 2 levels, including the Most Distinguished and Frank Medina awards
- 3 from SWATA in 1999 and 2001, respectively; and
- WHEREAS, Deeply concerned about the health and well-being of
- 5 student-athletes, Dennis Hart contributed to his fellow citizens
- 6 with his outstanding advocacy for Natasha's Law, and Representative
- 7 Price expresses his gratitude for Mr. Hart's role in achieving this
- 8 notable legislative victory; now, therefore, be it
- 9 RESOLVED, That the House of Representatives of the 82nd Texas
- 10 Legislature hereby honor Dennis Hart for his successful efforts to
- 11 heighten awareness of the dangers associated with concussion
- 12 sustained by student-athletes and extend to him sincere best wishes
- 13 for the future; and, be it further
