1-10 relating to the prosecution, punishment, and certain criminal and
1-11 civil consequences of offenses involving or related to the
1-12 trafficking of persons and to certain protections for victims of
1-13 those offenses.

1-14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-15 ARTICLE 1. TRAFFICKING OF PERSONS AND COMPELLING PROSTITUTION

1-16 SECTION 1.01. Section 20A.01, Penal Code, is amended to
1-17 read as follows:

1-18 Sec. 20A.01. DEFINITIONS. In this chapter:

1-19 (1) "Child" means a person younger than 18 years of
1-20 age.

1-21 (2) "Forced labor or services" means labor or
1-22 services, other than labor or services that constitute sexual
1-23 conduct [including conduct that constitutes an offense under
1-24 Section 43.02], that are performed or provided by another person
1-25 and obtained through an actor's use of force, fraud, or coercion[+
1-26 [(A) causing or threatening to cause bodily
1-27 injury to the person or another person or otherwise causing the
1-28 person performing or providing labor or services to believe that
1-29 the person or another person will suffer bodily injury;
1-30 [(B) restraining or threatening to restrain the
1-31 person or another person in a manner described by Section 20.01(1)
1-32 or causing the person performing or providing labor or services to
1-33 believe that the person or another person will be restrained;
1-34 [(C) knowingly destroying, concealing, removing,
1-35 confiscating, or withholding from the person or another person, or
1-36 threatening to destroy, conceal, remove, confiscate, or withhold
1-37 from the person or another person, the person's actual or
1-38 purported:
1-39 [(i) government records;
1-40 [(ii) identifying information; or
1-41 [(iii) personal property;
1-42 [(D) threatening the person with abuse of the law
1-43 or the legal process in relation to the person or another person;
1-44 [(E) threatening to report the person or another
1-45 person to immigration officials or other law enforcement officials
1-46 or otherwise blackmailing or extorting the person or another
1-47 person;
1-48 [(F) exerting financial control over the person
1-49 or another person by placing the person or another person under the
1-50 actor's control as security for a debt to the extent that:
1-51 [(i) the value of the services provided by
1-52 the person or another person as reasonably assessed is not applied
1-53 toward the liquidation of the debt;
1-54 [(ii) the duration of the services provided
1-55 by the person or another person is not limited and the nature of the
1-56 services provided by the person or another person is not defined; or
1-57 [(iii) the principal amount of the debt
1-58 does not reasonably reflect the value of the items or services for
1-59 which the debt was incurred; or
1-60 [(G) using any scheme, plan, or pattern intended
1-61 to cause the person to believe that the person or another person
1-62 will be subjected to serious harm or restraint if the person does
1-63 not perform or provide the labor or services].

2-1 (3) "Sexual conduct" has the meaning assigned by
2-2 Section 43.25.
2-3 (4) [~~2~~] "Traffic" means to transport, entice,
2-4 recruit, harbor, provide, or otherwise obtain another person by any
2-5 means.
2-6 SECTION 1.02. Section 20A.02, Penal Code, is amended by
2-7 amending Subsections (a) and (b) and adding Subsection (d) to read
2-8 as follows:
2-9 (a) A person commits an offense if the person knowingly:
2-10 (1) traffics another person with the intent [~~or~~
2-11 ~~knowledge~~] that the trafficked person [~~will~~] engage in forced labor
2-12 or services; [~~or~~]
2-13 (2) receives a benefit [~~benefits~~] from participating
2-14 in a venture that involves an activity described by Subdivision
2-15 (1), including by receiving labor or services the person knows are
2-16 forced labor or services;
2-17 (3) traffics another person and, through force, fraud,
2-18 or coercion, causes the trafficked person to engage in conduct
2-19 prohibited by:
2-20 (A) Section 43.02 (Prostitution);
2-21 (B) Section 43.03 (Promotion of Prostitution);
2-22 (C) Section 43.04 (Aggravated Promotion of
2-23 Prostitution); or
2-24 (D) Section 43.05 (Compelling Prostitution);
2-25 (4) receives a benefit from participating in a venture
2-26 that involves an activity described by Subdivision (3) or engages
2-27 in sexual conduct with a person trafficked in the manner described
2-28 in Subdivision (3);
2-29 (5) traffics a child with the intent that the
2-30 trafficked child engage in forced labor or services;
2-31 (6) receives a benefit from participating in a venture
2-32 that involves an activity described by Subdivision (5), including
2-33 by receiving labor or services the person knows are forced labor or
2-34 services;
2-35 (7) traffics a child and by any means causes the
2-36 trafficked child to engage in, or become the victim of, conduct
2-37 prohibited by:
2-38 (A) Section 21.02 (Continuous Sexual Abuse of
2-39 Young Child or Children);
2-40 (B) Section 21.11 (Indecency with a Child);
2-41 (C) Section 22.011 (Sexual Assault);
2-42 (D) Section 22.021 (Aggravated Sexual Assault);
2-43 (E) Section 43.02 (Prostitution);
2-44 (F) Section 43.03 (Promotion of Prostitution);
2-45 (G) Section 43.04 (Aggravated Promotion of
2-46 Prostitution);
2-47 (H) Section 43.05 (Compelling Prostitution);
2-48 (I) Section 43.25 (Sexual Performance by a
2-49 Child);
2-50 (J) Section 43.251 (Employment Harmful to
2-51 Children); or
2-52 (K) Section 43.26 (Possession or Promotion of
2-53 Child Pornography); or
2-54 (8) receives a benefit from participating in a venture
2-55 that involves an activity described by Subdivision (7) or engages
2-56 in sexual conduct with a child trafficked in the manner described in
2-57 Subdivision (7).
2-58 (b) Except as otherwise provided by this subsection, an
2-59 offense under this section is a felony of the second degree. An
2-60 offense under this section is a felony of the first degree if:
2-61 (1) the applicable conduct constitutes an offense
2-62 under Subsection (a)(5), (6), (7), or (8) [Section 43.05 or 43.25
2-63 and the person who is trafficked is a child younger than 18 years of
2-64 age at the time of the offense], regardless of whether the actor
2-65 knows the age of the child at the time the actor commits the
2-66 offense; or
2-67 (2) the commission of the offense results in the death
2-68 of the person who is trafficked.
2-69 (d) If the victim of an offense under Subsection (a)(7)(A)

3-1 is the same victim as a victim of an offense under Section 21.02, a
3-2 defendant may not be convicted of the offense under Section 21.02 in
3-3 the same criminal action as the offense under Subsection (a)(7)(A)
3-4 unless the offense under Section 21.02:

- 3-5 (1) is charged in the alternative;
- 3-6 (2) occurred outside the period in which the offense
3-7 alleged under Subsection (a)(7)(A) was committed; or
- 3-8 (3) is considered by the trier of fact to be a lesser

(B) for which a plea agreement was reached in a case in which the accused was charged with more than one offense listed in Paragraph (A) committed against a victim younger than 17 years of age at the time of the commission of the offense regardless of whether the accused is charged with violations of the same section more than once or is charged with violations of more than one section;

(3) an offense:

(A) under Section 21.15 or 43.26, regardless of whether the accused is convicted of violations of the same section more than once or is convicted of violations of both sections; or

(B) for which a plea agreement was reached in a case in which the accused was charged with more than one offense listed in Paragraph (A), regardless of whether the accused is charged with violations of the same section more than once or is charged with violations of both sections; ~~[or]~~

(4) an offense for which the judgment in the case contains an affirmative finding under Article 42.0197, Code of Criminal Procedure; or

(5) an offense:

(A) under Section 20A.02 or 43.05, regardless of whether the accused is convicted of violations of the same section more than once or is convicted of violations of both sections; or

(B) for which a plea agreement was reached in a case in which the accused was charged with more than one offense listed in Paragraph (A), regardless of whether the accused is charged with violations of the same section more than once or is charged with violations of both sections.

SECTION 6.02. Subdivision (2), Subsection (c), Section 12.42, Penal Code, is amended to read as follows:

ARTICLE 7. TRANSITION; EFFECTIVE DATE

16-54 SECTION 7.01. The change in law made by this Act applies
16-55 only to an offense committed on or after the effective date of this
16-56 Act. An offense committed before the effective date of this Act is
16-57 governed by the law in effect on the date the offense was committed,
16-58 and the former law is continued in effect for that purpose. For
16-59 purposes of this section, an offense was committed before the
16-60 effective date of this Act if any element of the offense occurred
16-61 before that date.
