- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 54.06(e), Family Code, is amended to
- 6 read as follows:
- 7 (e) The court shall apply the child support guidelines under
- 8 Subchapter C, Chapter 154, in an order requiring the payment of
- 9 child support under this section. The court shall also require in
- 10 an order to pay child support under this section that health
- 11 insurance and dental insurance be provided for the child.
- 12 Subchapter D, Chapter 154, applies to an order requiring health
- 13 insurance and dental insurance for a child under this section.
- SECTION 2. Section 101.006, Family Code, is amended to read
- 15 as follows:
- 16 Sec. 101.006. CHILD SUPPORT SERVICES. "Child support
- 17 services" means administrative or court actions to:
- 18 (1) establish paternity;
- 19 (2) establish, modify, or enforce child support, [or]
- 20 medical support, or dental support obligations;
- 21 (3) locate absent parents; or
- 22 (4) cooperate with other states in these actions and
- 23 any other action authorized or required under Part D of Title IV of
- 24 the federal Social Security Act (42 U.S.C. Section 651 et seq.) or

- 1 Chapter 231.
- 2 SECTION 3. Chapter 101, Family Code, is amended by adding
- 3 Sections 101.0094 and 101.0095 to read as follows:
- 4 Sec. 101.0094. DENTAL INSURANCE. "Dental insurance" means
- 5 insurance coverage that provides preventive dental care and other
- 6 dental services, including usual dentist services, office visits,
- 7 examinations, X-rays, and emergency services, that may be provided
- 8 through a single service health maintenance organization or other
- 9 private or public organization.
- 10 Sec. 101.0095. DENTAL SUPPORT. "Dental support" means
- 11 periodic payments or a lump-sum payment made under an order to cover
- 12 <u>dental expenses</u>, including dental insurance coverage, incurred for
- 13 the benefit of a child.
- 14 SECTION 4. Section 101.012, Family Code, is amended to read
- 15 as follows:
- Sec. 101.012. EMPLOYER. "Employer" means a person,
- 17 corporation, partnership, workers' compensation insurance carrier,
- 18 governmental entity, the United States, or any other entity that
- 19 pays or owes earnings to an individual. The term includes, for the
- 20 purposes of enrolling dependents in a group health or dental
- 21 insurance plan, a union, trade association, or other similar
- 22 organization.
- SECTION 5. Section 101.024(b), Family Code, is amended to
- 24 read as follows:
- 25 (b) For purposes of establishing, determining the terms of,
- 26 modifying, or enforcing an order, a reference in this title to a
- 27 parent includes a person ordered to pay child support under Section

- 1 154.001(a-1) or to provide medical support or dental support for a
- 2 child.
- 3 SECTION 6. Section 101.034, Family Code, is amended to read
- 4 as follows:
- 5 Sec. 101.034. TITLE IV-D CASE. "Title IV-D case" means an
- 6 action in which services are provided by the Title IV-D agency under
- 7 Part D, Title IV, of the federal Social Security Act (42 U.S.C.
- 8 Section 651 et seq.), relating to the location of an absent parent,
- 9 determination of parentage, or establishment, modification, or
- 10 enforcement of a child support, [or medical support, or dental
- 11 <u>support</u> obligation.
- 12 SECTION 7. Section 153.611, Family Code, is amended to read
- 13 as follows:
- 14 Sec. 153.611. EXCEPTION FOR CERTAIN TITLE IV-D
- 15 PROCEEDINGS. Notwithstanding any other provision of this
- 16 subchapter, this subchapter does not apply to a proceeding in a
- 17 Title IV-D case relating to the determination of parentage or
- 18 establishment, modification, or enforcement of a child support $\underline{\underline{\hspace{0.5cm}}}$
- 19 [or] medical support, or dental support obligation.
- SECTION 8. Section 154.008, Family Code, is amended to read
- 21 as follows:
- Sec. 154.008. PROVISION FOR MEDICAL SUPPORT AND DENTAL
- 23 SUPPORT. The court shall order medical support and dental support
- 24 for the child as provided by Subchapters B and D.
- 25 SECTION 9. Section 154.015(c), Family Code, is amended to
- 26 read as follows:
- 27 (c) For purposes of this section, the court of continuing

- 1 jurisdiction shall determine the amount of the unpaid child support
- 2 obligation for each child of the deceased obligor. In determining
- 3 the amount of the unpaid child support obligation, the court shall
- 4 consider all relevant factors, including:
- 5 (1) the present value of the total amount of monthly
- 6 periodic child support payments that would become due between the
- 7 month in which the obligor dies and the month in which the child
- 8 turns 18 years of age, based on the amount of the periodic monthly
- 9 child support payments under the child support order in effect on
- 10 the date of the obligor's death;
- 11 (2) the present value of the total amount of health
- 12 insurance and dental insurance premiums payable for the benefit of
- 13 the child from the month in which the obligor dies until the month
- 14 in which the child turns 18 years of age, based on the cost of health
- 15 insurance and dental insurance for the child ordered to be paid on
- 16 the date of the obligor's death;
- 17 (3) in the case of a disabled child under 18 years of
- 18 age or an adult disabled child, an amount to be determined by the
- 19 court under Section 154.306;
- 20 (4) the nature and amount of any benefit to which the
- 21 child would be entitled as a result of the obligor's death,
- 22 including life insurance proceeds, annuity payments, trust
- 23 distributions, social security death benefits, and retirement
- 24 survivor benefits; and
- 25 (5) any other financial resource available for the
- 26 support of the child.
- 27 SECTION 10. Section 154.016(b), Family Code, is amended to

- 1 read as follows:
- 2 (b) In determining the nature and extent of the obligation
- 3 to provide for the support of the child in the event of the death of
- 4 the obligor, the court shall consider all relevant factors,
- 5 including:
- 6 (1) the present value of the total amount of monthly
- 7 periodic child support payments from the date the child support
- 8 order is rendered until the month in which the child turns 18 years
- 9 of age, based on the amount of the periodic monthly child support
- 10 payment under the child support order;
- 11 (2) the present value of the total amount of health
- 12 insurance and dental insurance premiums payable for the benefit of
- 13 the child from the date the child support order is rendered until
- 14 the month in which the child turns 18 years of age, based on the cost
- of health insurance and dental insurance for the child ordered to be
- 16 paid; and
- 17 (3) in the case of a disabled child under 18 years of
- 18 age or an adult disabled child, an amount to be determined by the
- 19 court under Section 154.306.
- SECTION 11. Sections 154.062(d) and (e), Family Code, are
- 21 amended to read as follows:
- 22 (d) The court shall deduct the following items from
- 23 resources to determine the net resources available for child
- 24 support:
- 25 (1) social security taxes;
- 26 (2) federal income tax based on the tax rate for a
- 27 single person claiming one personal exemption and the standard

- 1 deduction;
- 2 (3) state income tax;
- 3 (4) union dues; and
- 4 (5) expenses for the cost of health insurance, dental
- 5 <u>insurance</u>, [ex] cash medical support, and cash dental support for
- 6 the obligor's child ordered by the court under <u>Sections</u> [<u>Section</u>]
- 7 154.182 and 154.1825.
- 8 (e) In calculating the amount of the deduction for health
- 9 care or dental coverage for a child under Subsection (d)(5), if the
- 10 obligor has other minor dependents covered under the same health or
- 11 <u>dental</u> insurance plan, the court shall divide the total cost to the
- 12 obligor for the insurance by the total number of minor dependents,
- 13 including the child, covered under the plan.
- 14 SECTION 12. Section 154.064, Family Code, is amended to
- 15 read as follows:
- 16 Sec. 154.064. MEDICAL SUPPORT AND DENTAL SUPPORT FOR CHILD
- 17 PRESUMPTIVELY PROVIDED BY OBLIGOR. The guidelines for support of a
- 18 child are based on the assumption that the court will order the
- 19 obligor to provide medical support and dental support for the child
- 20 in addition to the amount of child support calculated in accordance
- 21 with those guidelines.
- SECTION 13. The heading to Subchapter D, Chapter 154,
- 23 Family Code, is amended to read as follows:
- 24 SUBCHAPTER D. MEDICAL SUPPORT AND DENTAL SUPPORT FOR CHILD
- 25 SECTION 14. Subchapter D, Chapter 154, Family Code, is
- 26 amended by adding Section 154.1815 to read as follows:
- Sec. 154.1815. DENTAL SUPPORT ORDER. (a) In this section,

- 1 "reasonable cost" means the cost of a dental insurance premium that
- 2 does not exceed three percent of the obligor's annual resources, as
- 3 described by Section 154.062(b), if the obligor is responsible
- 4 under a dental support order for the cost of dental insurance
- 5 coverage for only one child. If the obligor is responsible under a
- 6 dental support order for the cost of dental insurance coverage for
- 7 more than one child, "reasonable cost" means the total cost of
- 8 dental insurance coverage for all children for which the obligor is
- 9 responsible under a dental support order that does not exceed three
- 10 percent of the obligor's annual resources, as described by Section
- 11 154.062(b).
- 12 (b) In a suit affecting the parent-child relationship or in
- 13 a proceeding under Chapter 159, the court shall render an order for
- 14 the dental support of the child as provided by this section and
- 15 <u>Section 154.1825.</u>
- 16 (c) Before a hearing on temporary orders, or a final order
- 17 if no hearing on temporary orders is held, the court shall require
- 18 the parties to the proceedings to disclose in a pleading or other
- 19 document whether the child is covered by dental insurance and, if
- 20 the child is covered, the identity of the insurer providing the
- 21 coverage, the policy number, which parent is responsible for
- 22 payment of any insurance premium for the coverage, whether the
- 23 coverage is provided through a parent's employment, and the cost of
- 24 the premium. If dental insurance is not in effect for the child,
- 25 the parties must disclose to the court whether either parent has
- 26 access to dental insurance at a reasonable cost to the obligor.
- 27 (d) In rendering temporary orders, the court shall, except

- 1 for good cause shown, order that any dental insurance coverage in
- 2 effect for the child continue in effect pending the rendition of a
- 3 final order, except that the court may not require the continuation
- 4 of any dental insurance that is not available to the parent at a
- 5 reasonable cost to the obligor. If dental insurance coverage is not
- 6 in effect for the child or if the insurance in effect is not
- 7 available at a reasonable cost to the obligor, the court shall,
- 8 except for good cause shown, order dental insurance coverage for
- 9 the child as provided by Section 154.1825.
- 10 <u>(e) On rendering a final order the court shall:</u>
- 11 (1) make specific findings with respect to the manner
- 12 in which dental insurance coverage is to be provided for the child,
- 13 in accordance with the priorities identified under Section
- 14 154.1825; and
- 15 (2) except for good cause shown or on agreement of the
- 16 parties, require the parent ordered to provide dental insurance
- 17 coverage for the child as provided by Section 154.1825 to produce
- 18 evidence to the court's satisfaction that the parent has applied
- 19 for or secured dental insurance or has otherwise taken necessary
- 20 action to provide for dental insurance coverage for the child, as
- 21 ordered by the court.
- 22 SECTION 15. Subchapter D, Chapter 154, Family Code, is
- 23 amended by adding Section 154.1825 to read as follows:
- Sec. 154.1825. DENTAL CARE COVERAGE FOR CHILD. (a) In this
- 25 section:
- 26 (1) "Accessibility" means the extent to which dental
- 27 insurance coverage for a child provides for the availability of

- 1 dental care within a reasonable traveling distance and time from
- 2 the child's primary residence, as determined by the court.
- 3 (2) "Reasonable cost" has the meaning assigned by
- 4 Section 154.1815(a).
- 5 (b) The court shall consider the cost, accessibility, and
- 6 quality of dental insurance coverage available to the parties and
- 7 shall give priority to dental insurance coverage available through
- 8 the employment of one of the parties if the coverage is available at
- 9 a reasonable cost to the obligor.
- 10 (c) In determining the manner in which dental care coverage
- 11 for the child is to be ordered, the court shall render its order in
- 12 accordance with the following priorities, unless a party shows good
- 13 cause why a particular order is not in the best interest of the
- 14 child:
- 15 (1) if dental insurance is available for the child
- 16 through a parent's employment or membership in a union, trade
- 17 association, or other organization at reasonable cost, the court
- 18 shall order that parent to include the child in the parent's dental
- 19 insurance;
- 20 (2) if dental insurance is not available for the child
- 21 under Subdivision (1) but is available to a parent from another
- 22 <u>source and at a reasonable cost, the court may order that parent to</u>
- 23 provide dental insurance for the child; or
- 24 (3) if dental insurance coverage is not available for
- 25 the child under Subdivision (1) or (2), the court shall order the
- 26 obligor to pay the obligee, in addition to any amount ordered under
- 27 the guidelines for child support, an amount, not to exceed three

- 1 percent of the obligor's annual resources, as described by Section
- 2 154.062(b), as cash dental support for the child.
- 3 (d) If the parent ordered to provide dental insurance under
- 4 Subsection (c)(1) or (2) is the obligee, the court shall order the
- 5 obligor to pay the obligee, as additional child support, an amount
- 6 equal to the actual cost of dental insurance for the child, but not
- 7 to exceed a reasonable cost to the obligor. In calculating the
- 8 actual cost of dental insurance for the child, if the obligee has
- 9 other minor dependents covered under the same dental insurance
- 10 plan, the court shall divide the total cost to the obligee for the
- 11 insurance by the total number of minor dependents, including the
- 12 child covered under the plan.
- 13 (e) If the court finds that neither parent has access to
- 14 private dental insurance at a reasonable cost to the obligor, the
- 15 court shall order the parent awarded the exclusive right to
- 16 <u>designate the child's primary residence or, to the extent permitted</u>
- 17 by law, the other parent to apply immediately on behalf of the child
- 18 for participation in any government medical assistance program or
- 19 health plan that provides dental coverage. If the child
- 20 participates in a government medical assistance program or health
- 21 plan that provides dental coverage, the court shall order cash
- 22 dental support under Subsection (c)(3).
- 23 <u>(f) An order requiring the payment of cash dental support</u>
- 24 under Subsection (c)(3) must allow the obligor to discontinue
- 25 payment of the cash dental support if:
- 26 (1) dental insurance for the child becomes available
- 27 to the obligor at a reasonable cost; and

- 1 (2) the obligor:
- 2 (A) enrolls the child in the insurance plan; and
- 3 (B) provides the obligee and, in a Title IV-D
- 4 case, the Title IV-D agency, the information required under Section
- 5 154.185.
- 6 SECTION 16. Section 154.183, Family Code, is amended to
- 7 read as follows:
- 8 Sec. 154.183. MEDICAL <u>AND DENTAL</u> SUPPORT ADDITIONAL SUPPORT
- 9 DUTY OF OBLIGOR. (a) An amount that an obligor is ordered to pay
- 10 as medical support or dental support for the child under this
- 11 chapter, including the costs of health insurance coverage or cash
- 12 medical support under Section 154.182 and the costs of dental
- 13 insurance or cash dental support under Section 154.1825:
- 14 (1) is in addition to the amount that the obligor is
- 15 required to pay for child support under the guidelines for child
- 16 support;
- 17 (2) is a child support obligation; and
- 18 (3) may be enforced by any means available for the
- 19 enforcement of child support, including withholding from earnings
- 20 under Chapter 158.
- 21 (b) If the court finds and states in the child support order
- 22 that the obligee will maintain health insurance coverage, dental
- 23 <u>insurance coverage</u>, or both, for the child at the obligee's
- 24 expense, the court shall increase the amount of child support to be
- 25 paid by the obligor in an amount not exceeding the actual cost to
- 26 the obligee for maintaining the [health insurance] coverage, as
- 27 provided under Sections [$\frac{\text{Section}}{\text{Section}}$] 154.182(b-1) and 154.1825(d).

- 1 (c) As additional child support, the court shall allocate
- 2 between the parties, according to their circumstances:
- 3 (1) the reasonable and necessary health care expenses,
- 4 including vision and dental expenses, of the child that are not
- 5 reimbursed by health or dental insurance or are not otherwise
- 6 covered by the amount of cash medical support ordered under Section
- 7 154.182 or cash dental support ordered under Section 154.1825
- $8 \left[\frac{154.182(b)(3)}{3}\right]$; and
- 9 (2) amounts paid by either party as deductibles or
- 10 copayments in obtaining health care or dental care services for the
- 11 child covered under a health insurance or dental insurance policy.
- SECTION 17. Sections 154.184(a) and (b), Family Code, are
- 13 amended to read as follows:
- 14 (a) Receipt of a medical support order requiring that health
- 15 insurance be provided for a child or a dental support order
- 16 requiring that dental insurance be provided for a child shall be
- 17 considered a change in the family circumstances of the employee or
- 18 member, for health insurance purposes and dental insurance
- 19 purposes, equivalent to the birth or adoption of a child.
- 20 (b) If the employee or member is eligible for dependent
- 21 health coverage or dependent dental coverage, the employer shall
- 22 automatically enroll the child for the first 31 days after the
- 23 receipt of the order or notice of the medical support order or the
- 24 dental support order under Section 154.186 on the same terms and
- 25 conditions as apply to any other dependent child.

- 2 shall order a parent providing health insurance or dental insurance
- 3 to furnish to either the obligee, obligor, or child support agency

- 5 the notice of rendition of the order is received:
- 6 (1) the social security number of the parent;
- 7 (2) the name and address of the parent's employer;
- 8 (3) with regard to health insurance:

- 26 (C) if the employer has dental insurance
- 27 available, the name of the dental insurance carrier, the number of

- 1 the policy, a copy of the policy and schedule of benefits, a dental

- 3 necessary to submit a claim; and
- 4 (D) if the employer is self-insured, a copy of
- 5 the schedule of benefits, a membership card, claim forms, and any
- 6 other information necessary to submit a claim.
- 7 (b) The court shall also order a parent providing health
- 8 insurance or dental insurance to furnish the obligor, obligee, or
- 9 child support agency with additional information regarding the
- 10 health insurance coverage or dental insurance coverage not later
- 11 than the 15th day after the date the information is received by the
- 12 parent.
- 13 SECTION 19. The heading to Section 154.186, Family Code, is
- 14 amended to read as follows:
- 15 Sec. 154.186. NOTICE TO EMPLOYER CONCERNING MEDICAL SUPPORT
- 16 OR DENTAL SUPPORT.
- SECTION 20. Section 154.186(a), Family Code, is amended to
- 18 read as follows:
- 19 (a) The obligee, obligor, or a child support agency of this
- 20 state or another state may send to the employer a copy of the order
- 21 requiring an employee to provide health insurance coverage or
- 22 dental insurance coverage for a child or may include notice of the
- 23 medical support order or dental support order in an order or writ of
- 24 withholding sent to the employer in accordance with Chapter 158.
- 25 SECTION 21. Sections 154.187(a), (b), (c), (d), (e), and
- 26 (g), Family Code, are amended to read as follows:
- 27 (a) An order or notice under this subchapter to an employer

- 1 directing that health insurance coverage or dental insurance coverage be provided to a child of an employee or member is binding 2 3 on a current or subsequent employer on receipt without regard to the date the order was rendered. If the employee or member is eligible 4 5 for dependent health coverage or dental coverage for the child, the employer shall immediately enroll the child in a health insurance 6 plan or dental insurance plan regardless of whether the employee is 7 8 enrolled in the plan. If dependent coverage is not available to the employee or member through the employer's health insurance plan or 9 10 dental insurance plan or enrollment cannot be made permanent or if the employer is not responsible or otherwise liable for providing 11 12 such coverage, the employer shall provide notice to the sender in accordance with Subsection (c). 13
- (b) If additional premiums are incurred as a result of adding the child to the health insurance plan or the dental insurance plan, the employer shall deduct the health insurance premium or the dental insurance premium from the earnings of the employee in accordance with Chapter 158 and apply the amount withheld to payment of the insurance premium.
- (c) An employer who has received an order or notice under this subchapter shall provide to the sender, by first class mail not later than the 30th day after the date the employer receives the order or notice, a statement that the child:
- (1) has been enrolled in the employer's health insurance plan, or is already enrolled in another health insurance plan or dental insurance plan in accordance with a previous child support, [ex] medical support, or

- 1 <u>dental support</u> order to which the employee is subject; or
- 2 (2) cannot be enrolled or cannot be enrolled
- 3 permanently in the employer's health insurance plan or dental
- 4 insurance plan and provide the reason why coverage or permanent
- 5 coverage cannot be provided.
- 6 (d) If the employee ceases employment or if the health
- 7 insurance coverage or dental insurance coverage lapses, the
- 8 employer shall provide to the sender, by first class mail not later
- 9 than the 15th day after the date of the termination of employment or
- 10 the lapse of the coverage, notice of the termination or lapse and of
- 11 the availability of any conversion privileges.
- 12 (e) On request, the employer shall release to the sender
- 13 information concerning the available health insurance coverage or
- 14 dental insurance coverage, including the name of the health
- 15 insurance carrier or dental insurance carrier, the policy number, a
- 16 copy of the policy and schedule of benefits, a health insurance or
- 17 dental insurance membership card, and claim forms.
- 18 (g) An employer who fails to enroll a child, fails to
- 19 withhold or remit premiums, [or cash medical support, or cash
- 20 dental support, or discriminates in hiring or employment on the
- 21 basis of a medical support order or notice or a dental support order
- 22 or notice under this subchapter shall be subject to the penalties
- 23 and fines in Subchapter C, Chapter 158.
- SECTION 22. Section 154.188, Family Code, is amended to
- 25 read as follows:
- Sec. 154.188. FAILURE TO PROVIDE OR PAY FOR REQUIRED HEALTH
- 27 INSURANCE OR DENTAL INSURANCE. A parent ordered to provide health

- 1 insurance or dental insurance or to pay the other parent additional
- 2 child support for the cost of health insurance or dental insurance
- 3 who fails to do so is liable for:
- 4 (1) necessary medical expenses or dental expenses of
- 5 the child, without regard to whether the expenses would have been
- 6 paid if health insurance or dental insurance had been provided; and
- 7 (2) the cost of health insurance premiums, dental
- 8 <u>insurance premiums</u>, or contributions, if any, paid on behalf of the

- 10 SECTION 23. Section 154.189, Family Code, is amended to

- 12 Sec. 154.189. NOTICE OF TERMINATION OR LAPSE OF INSURANCE
- 13 COVERAGE. (a) An obligor ordered to provide health insurance
- 14 coverage or dental insurance coverage for a child must notify the
- 15 obligee and any child support agency enforcing a support obligation
- 16 against the obligor of the:
- 17 (1) termination or lapse of health insurance coverage
- 18 or dental insurance coverage for the child not later than the 15th
- 19 day after the date of a termination or lapse; and
- 20 (2) availability of additional health insurance or
- 21 <u>dental insurance</u> to the obligor for the child after a termination or
- 22 lapse of coverage not later than the 15th day after the date the
- 23 insurance becomes available.
- 24 (b) If termination of coverage results from a change of
- 25 employers, the obligor, the obligee, or the child support agency
- 26 may send the new employer a copy of the order requiring the employee
- 27 to provide health insurance or dental insurance for a child or

- 1 notice of the medical support order or the dental support order as
- 2 provided by this subchapter.
- 3 SECTION 24. Section 154.190, Family Code, is amended to

- 5 Sec. 154.190. REENROLLING CHILD FOR INSURANCE COVERAGE.
