Section 3, Chapter 286 (H.B. 4765), Acts of the 10 81st Legislature, Regular Session, 2009, which amended former 11 12 Subsection (a), Section 171.0021, Tax Code, is repealed. 13 SECTION 4. Section 171.0021, Tax Code, is repealed. 14 SECTION 5. Section 171.1016(d), Tax Code, is repealed. SECTION 6. This Act takes effect immediately if it receives 15 a vote of two-thirds of all the members elected to each house, as 16 provided by Section 39, Article III, Texas Constitution. If this 17 Act does not receive the vote necessary for immediate effect, this 18 Act takes effect September 1, 2011. 19
