4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 42.0421, Human Resources Code, is
6	amended by adding Subsections (f) and (g) to read as follows:
7	(f) The training required by this section must be
8	appropriately targeted and relevant to the age of the children who
9	will receive care from the individual receiving training and must
10	be provided by a person who:
11	(1) is a training provider registered with the Texas
12	Early Care and Education Career Development System's Texas Trainer
13	Registry that is maintained by the Texas Head Start State
14	Collaboration Office;
15	(2) is an instructor at a public or private secondary
16	school or at a public or private institution of higher education, as
17	defined by Section 61.801, Education Code, who teaches early
18	childhood development or another relevant course, as determined by
19	rules adopted by the commissioner of education and the commissioner
20	of higher education;
21	(3) is an employee of a state agency with relevant
22	<pre>expertise;</pre>
23	(4) is a physician, psychologist, licensed
24	professional counselor, social worker, or registered nurse;

- 1 (5) holds a generally recognized credential or
- 2 possesses documented knowledge relevant to the training the person
- 3 will provide;
- 4 <u>(6) is a registered family home care provider or</u>
- 5 director of a day-care center or group day-care home in good
- 6 standing with the department, if applicable, and who:
- 7 (A) has demonstrated core knowledge in child
- 8 <u>development and caregiving; and</u>
- 9 <u>(B) is only providing training at the home or</u>
- 10 center in which the provider or director and the person receiving
- 11 training are employed; or
- 12 <u>(7)</u> has at least two years of experience working in
- 13 child development, a child development program, early childhood
- 14 education, a childhood education program, or a Head Start or Early
- 15 Head Start program and:
- (A) has been awarded a Child Development
- 17 Associate (CDA) credential; or
- 18 (B) holds at least an associate's degree in child
- 19 development, early childhood education, or a related field.
- 20 (g) A person described by Subsection (f)(6) may provide
- 21 training under this section only if the department has not taken an
- 22 <u>action under Section 42.071, 42.072, or 42.078, other than an</u>
- 23 evaluation, against the license, listing, or registration of the
- 24 person or the home or center for which the person is a provider or
- 25 director during the two-year period preceding the date on which the
- 26 person provides the training.
- 27 SECTION 2. This Act takes effect January 1, 2012.
