## A BILL TO BE ENTITLED

AN ACT

2 relating to attorney's fees and other amounts taxed as costs in 3 guardianship proceedings.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 665A, Texas Probate Code, is amended to 6 read as follows:

Sec. 665A. PAYMENT FOR PROFESSIONAL SERVICES. 7 The court shall order the payment of a fee in an amount set by the court that 8 9 is fair and just as compensation to the attorneys, mental health professionals, and interpreters appointed under this chapter, as 10 11 applicable, to be taxed as costs in the case. The court may 12 allocate attorney's fees taxed as costs under this section among the parties as the court finds is fair and just. If after examining 13 14 the proposed ward's assets the court determines the proposed ward is unable to pay for costs allocated to the proposed ward for 15 services provided by an attorney, a mental health professional, or 16 an interpreter appointed under this chapter, as applicable, the 17 county is responsible for those costs [the cost of those services]. 18

19 SECTION 2. Section 665B, Texas Probate Code, as amended by 20 Chapters 314 (H.B. 587) and 930 (H.B. 3080), Acts of the 81st 21 Legislature, Regular Session, 2009, is reenacted and amended to 22 read as follows:

23 Sec. 665B. PAYMENT OF ATTORNEY'S FEES TO CERTAIN ATTORNEYS.24 (a) A court that creates a guardianship or creates a management

trust under Section 867 of this code for a ward under this chapter, 1 on request of a person who filed an application to be appointed 2 3 guardian of the proposed ward, an application for the appointment of another suitable person as guardian of the proposed ward, or an 4 5 application for the creation of the management trust, may authorize the payment of reasonable and necessary attorney's fees, as 6 determined by the court, in amounts the court considers fair and 7 8 just, to an attorney who represents the person who filed the application at the application hearing, regardless of whether the 9 10 person is appointed the ward's guardian or whether a management trust is created, from: 11

12 (1) <u>subject to Subsection (a-1) of this section, the</u> 13 <u>parties to the guardianship proceeding, allocated as the court</u> 14 <u>finds is fair and just; or</u>

15 (2) subject to Subsection (a-1) of this section, 16 available funds of the [ward's estate or] management trust, if 17 created.

18 <u>(a-1) The court may authorize amounts allocated to the</u> 19 ward's estate under Subsection (a)(1) of this section or amounts to 20 be paid from available funds of the management trust as provided by 21 Subsection (a)(2) of this section to instead be paid from the county 22 treasury, [; or

23 [<del>(2)</del>] subject to Subsection (c) of this section, [the 24 county treasury] if:

25 (1) [(A)] the ward's estate or[, if created,]
26 management trust[,] is insufficient to pay [for] the amounts
27 [services provided by the attorney]; and

S.B. No. 286 1 <u>(2)</u> [<del>(B)</del>] funds in the county treasury are budgeted 2 for that purpose.

3 (b) The court may not authorize attorney's fees under this 4 section unless the court finds that the applicant acted in good 5 faith and for just cause in the filing and prosecution of the 6 application.

7 (c) The court may authorize the payment of attorney's fees 8 from the county treasury under Subsection <u>(a-1)</u> [<del>(a)</del>] of this 9 section only if the court is satisfied that the attorney to whom the 10 fees will be paid has not received, and is not seeking, payment for 11 the services described by that subsection from any other source.

SECTION 3. Section 669(a), Texas Probate Code, is amended to read as follows:

14 (a) Except as provided by Subsection (b) of this section or 15 Section 665A or 665B(a) of this code, in a guardianship matter, the cost of the proceeding, including the cost of the guardian ad litem 16 17 or court visitor, shall be set in an amount the court considers fair and just and shall be paid out of the guardianship estate, or, if 18 19 the estate is insufficient to pay for the cost of the proceeding, the cost of the proceeding shall be paid out of the county treasury, 20 and the judgment of the court shall be issued accordingly. 21

22 SECTION 4. The changes in law made by this Act apply to a 23 guardianship created before, on, or after the effective date of 24 this Act.

25 SECTION 5. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this

Act does not receive the vote necessary for immediate effect, this
 Act takes effect September 1, 2011.
