A BILL TO BE ENTITLED

1 AN ACT relating to changes in the single-member district boundaries of the 2 Barton Springs-Edwards Aquifer Conservation District. 3 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 8802.053, Special District Local Laws 5 6 Code, is amended by amending Subsection (c) and adding Subsection 7 (c-1) to read as follows: 8 (c) As soon as practicable after the publication of each federal decennial census, the board shall revise the single-member 9 10 districts as the board considers appropriate to reflect population 11 changes. 12 (c-1) In this subsection, a reference to a highway, street, 13 road, avenue, boulevard, or lane means the centerline of that highway, street, road, avenue, boulevard, or lane. When the board 14 revises the single-member districts [under this subsection], the 15 board shall place two of the districts wholly within the territory 16 17 described as follows: Beginning at the eastern district boundary and the Colorado River, then south along the eastern district 18 boundary to the intersection of Interstate Highway 35 and Slaughter 19 Lane; then west along Slaughter Lane to the district boundary, then 20 north along the district boundary to the Colorado River, then east 21

1 Austin, as those boundaries exist at that time; or

2 [(2) within the boundaries of the city of Austin, as 3 those boundaries exist at that time, but also including 4 unincorporated areas or other municipalities that are surrounded 5 wholly or partly by the boundaries of the city of Austin if the 6 areas or municipalities are noncontiguous to the territory of any 7 other single-member district].

8 SECTION 2. Subchapter B, Chapter 8802, Special District 9 Local Laws Code, is amended by adding Section 8802.054 to read as 10 follows:

Sec. 8802.054. APPLICABILITY OF OTHER LAW. Section 36.059(b), Water Code, does not apply to the district.

SECTION 3. Subsection (b), Section 8802.051, and Subsection (d), Section 8802.053, Special District Local Laws Code, are repealed.

16 SECTION 4. (a) The legal notice of the intention to 17 introduce this Act, setting forth the general substance of this 18 Act, has been published as provided by law, and the notice and a 19 copy of this Act have been furnished to all persons, agencies, 20 officials, or entities to which they are required to be furnished 21 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 22 Government Code.

(b) The governor has submitted the notice and Act to the24 Texas Commission on Environmental Quality.

(c) The Texas Commission on Environmental Quality has filed
its recommendations relating to this Act with the governor,
lieutenant governor, and speaker of the house of representatives

2 (d) All requirements of the constitution and laws of this 3 state and the rules and procedures of the legislature with respect 4 to the notice, introduction, and passage of this Act are fulfilled 5 and accomplished.

6 SECTION 5. This Act takes effect September 1, 2011.
