S.B. No. 307

A BILL TO BE ENTITLED

1 AN ACT  
2 relating to the composition of the districts for the election of  
3 members of the State Board of Education.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 ARTICLE I

6 SECTION 1. (a) The members of the State Board of Education  
7 are elected from the districts described by Article II of this Act.

8 (b) One member is elected from each district established by  
9 this Act.

10 (c) The districts established by this Act are identified as  
11 PLANE100 on the redistricting computer system operated by the Texas  
12 Legislative Council.

13 (d) For purposes of Section 7.104, Education Code, this Act  
14 constitutes a decennial reapportionment.

15 ARTICLE II

3 ARTICLE III

4 SECTION 1. In this Act, "tract," "block group," and "block"  
5 mean the geographic areas identified by those terms on the 2000  
6 Census TIGER/Line File, prepared by the federal Bureau of the  
7 Census for the Twenty-second Decennial Census of the United States,  
8 enumerated as of April 1, 2000.

9 SECTION 2. It is the intention of the Texas Legislature  
10 that, if any county, tract, block group, block, or other geographic  
11 area has erroneously been left out of this Act, a court reviewing  
12 this Act should include that area in the appropriate district in  
13 accordance with the intent of the legislature, using any available  
14 evidence of that intent, including evidence such as that used by the  
15 Supreme Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W.  
16 749 (1922).

17 SECTION 3. (a) Section 7.101(a), Education Code, is  
18 amended to read as follows:

19 (a) The State Board of Education is composed of 15 members  
20 elected from districts. [~~Each district from which a board member is  
21 elected is composed as provided by former Sections 11.2101(b)-(t),  
22 as enacted by Chapter 2, Acts of the 72nd Legislature, 2nd Called  
23 Session, 1991.~~]

24 (b) This Act supersedes all previous enactments or orders  
25 adopting districts for the State Board of Education. All previous  
26 acts of the legislature adopting districts for the State Board of  
27 Education are repealed.

1           SECTION 4. The districts set out in Article II of this Act  
2 apply to the election of the members of the State Board of Education  
3 beginning with the primary and general elections in 2012 for  
4 members of the board in 2013. This Act does not affect the  
5 membership or districts of the board before January 1, 2013.

6           SECTION 5. This Act takes effect immediately if it receives  
7 a vote of two-thirds of all the members elected to each house, as  
8 provided by Section 39, Article III, Texas Constitution. If this  
9 Act does not receive the vote necessary for immediate effect, this  
10 Act takes effect on the 91st day after the last day of the  
11 legislative session.
