SECTION 5. The change in law made by this Act applies only 18 to a fee collected on conviction of an offense committed on or after 19 the effective date of this Act. A fee collected on conviction of an 20 offense committed before the effective date of this Act is covered 21 by the law in effect when the offense was committed, and the former 22 23 law is continued in effect for that purpose. For purposes of this 24 section, an offense was committed before the effective date of this Act if any element of the offense occurred before that date. 25

26 SECTION 6. This Act takes effect September 1, 2011.
