1-7 AN ACT

1-8 relating to the name and powers of the Red River Redevelopment
1-9 Authority.

1-10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-11 SECTION 1. The heading to Chapter 3503, Special District
1-12 Local Laws Code, is amended to read as follows:

1-13 CHAPTER 3503. TEXAMERICAS CENTER [~~RED RIVER REDEVELOPMENT~~
1-14 ~~AUTHORITY~~]

1-15 SECTION 2. Subdivision (1), Section 3503.001, Special
1-16 District Local Laws Code, is amended to read as follows:

1-17 (1) "Authority" means the TexAmericas Center [~~Red~~
1-18 ~~River Redevelopment Authority~~].

1-19 SECTION 3. Subchapter C, Chapter 3503, Special District
1-20 Local Laws Code, is amended by adding Section 3503.110 to read as
1-21 follows:

1-22 Sec. 3503.110. ASSUMED NAME. The authority may conduct
1-23 business under an assumed name by filing an assumed name
1-24 certificate under Subchapter C, Chapter 71, Business & Commerce
1-25 Code, and complying with that chapter in the same manner as an
1-26 incorporated business.

1-27 SECTION 4. Subsection (a), Section 9601.005, Special
1-28 District Local Laws Code, is amended to read as follows:

1-29 (a) The district is composed of the following members:

- 1-30 (1) the City of Annona;
- 1-31 (2) the City of Avery;
- 1-32 (3) the City of DeKalb;
- 1-33 (4) the City of Hooks;
- 1-34 (5) the City of Maud;
- 1-35 (6) the City of New Boston;
- 1-36 (7) the City of Texarkana, Texas;
- 1-37 (8) the City of Wake Village; and
- 1-38 (9) the TexAmericas Center [~~Red River Redevelopment~~
1-39 ~~Authority~~].

1-40 SECTION 5. Subsection (a), Section 9601.006, Special
1-41 District Local Laws Code, is amended to read as follows:

1-42 (a) The territory of the district is composed of all the
1-43 territory contained in:

1-44 (1) the cities of Annona, Avery, DeKalb, Hooks, Maud,
1-45 New Boston, Texarkana, Texas, and Wake Village; and

1-46 (2) the TexAmericas Center [~~Red River Redevelopment~~
1-47 ~~Authority~~], the boundaries of which are described by Section
1-48 3503.004, including territory that has been or may be added under
1-49 Section 3503.005.

1-50 SECTION 6. Section 3503.153, Special District Local Laws
1-51 Code, is repealed.

1-52 SECTION 7. A reference in law to the Red River Redevelopment
1-53 Authority means the TexAmericas Center.

1-54 SECTION 8. This Act takes effect immediately if it receives
1-55 a vote of two-thirds of all the members elected to each house, as
1-56 provided by Section 39, Article III, Texas Constitution. If this
1-57 Act does not receive the vote necessary for immediate effect, this
1-58 Act takes effect September 1, 2011.
