

A BILL TO BE ENTITLED

AN ACT

relating to the creation, administration, powers, and duties of a county assistance district.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 387.003, Local Government Code, is amended by amending Subsections (a), (b), (b-1), (c), (e), (f), and (h) and adding Subsections (a-1), (i), and (j) to read as follows:

(a) The commissioners court of the county may call an election on the question of creating a county assistance district under this chapter. More than one county assistance district may be created in a county.

(a-1) A district may ~~to~~ perform the following functions in the district:

(1) the construction, maintenance, or improvement of roads or highways;

(2) the provision of law enforcement and detention services;

(3) the maintenance or improvement of libraries, museums, parks, or other recreational facilities;

(4) the provision of services that benefit the public health or welfare, including the provision of firefighting and fire prevention services; or

(5) the promotion of economic development and tourism.

(b) The order calling the election must:

1           (1) define the boundaries of the district to include  
2 any portion of the county in which the combined tax rate of all  
3 local sales and use taxes imposed, including the rate to be imposed  
4 by the district if approved at the election, would not exceed the  
5 maximum combined rate of sales and use taxes imposed by political  
6 subdivisions of this state that is prescribed by Sections 321.101  
7 and 323.101, Tax Code [~~two percent~~]; and

8           (2) call for the election to be held within those  
9 boundaries.

10          (b-1) If the proposed district includes any territory of a  
11 municipality, the commissioners court shall send notice by  
12 certified mail to the governing body of the municipality of the  
13 commissioners court's intent to create the district. If the  
14 municipality has created a development corporation under Chapter  
15 504 or 505, the commissioners court shall also send the notice to  
16 the board of directors of the corporation. The commissioners court  
17 must send the notice not later than the 60th day before the date the  
18 commissioners court orders the election. The governing body of the  
19 municipality may exclude the territory of the municipality from the  
20 proposed district by sending notice by certified mail to the  
21 commissioners court of the governing body's desire to exclude the  
22 municipal territory from the district. The governing body must  
23 send the notice not later than the 45th day after the date the  
24 governing body receives notice from the commissioners court under  
25 this subsection. The territory of a municipality that is excluded  
26 under this subsection may subsequently be included in:

27           (1) the district in an election held under Subsection

1 (f) with the consent of the municipality; or  
2 (2) another district after complying with the  
3 requirements of this subsection and after an election held under  
4 Subsection (f).

5 (c) The ballot at the election must be printed to permit  
6 voting for or against the proposition: "Authorizing the creation  
7 of the \_\_\_\_ County Assistance District No.\_\_\_\_ (insert name of  
8 district) and the imposition of a sales and use tax at the rate of  
9 \_\_\_\_ [~~of one~~] percent (insert [~~one-eighth, one-fourth,~~  
10 ~~three-eighths, or one-half, as~~] appropriate rate) for the purpose  
11 of financing the operations of the district."

12 (e) If a majority of the votes received at the election are  
13 against the creation of the district, the district is not created.  
14 The failure to approve the creation of a district under this  
15 subsection does not affect the authority of the county to call one  
16 or more elections [~~another election~~] on the question of creating  
17 one or more [~~a~~] county assistance districts [~~district may not be~~  
18 ~~held in the county before the first anniversary of the most recent~~  
19 ~~election concerning the creation of a district~~].

20 (f) The commissioners court may call an election to be held  
21 in an area of the county that is not located in a district created  
22 under this section to determine whether the area should be included  
23 in the district and whether the district's sales and use tax should  
24 be imposed in the area. An election may not be held in an area in  
25 which the combined tax rate of all local sales and use taxes  
26 imposed, including the rate to be imposed by the district if  
27 approved at the election, would exceed the maximum combined rate of

1 sales and use taxes imposed by political subdivisions of this state  
2 that is prescribed by Sections 321.101 and 323.101, Tax Code [~~two~~  
3 percent].

4 (h) If more than one election to authorize a local sales and  
5 use tax is held on the same day in the area of a proposed district or  
6 an area proposed to be added to a district and if the resulting  
7 approval by the voters would cause the imposition of a local sales  
8 and use tax in any area to exceed the maximum combined rate of sales  
9 and use taxes of political subdivisions of this state that is  
10 prescribed by Sections 321.101 and 323.101, Tax Code [~~two percent]~~,  
11 only a tax authorized at an election under this section may be  
12 imposed.

13 (i) In addition to the authority to include an area in a  
14 district under Subsection (f), the governing body of a district by  
15 order may include an area in the district on receipt of a petition  
16 or petitions signed by the owner or owners of the majority of the  
17 land in the area to be included in the district. If there are no  
18 registered voters in the area to be included in the district, no  
19 election is required.

20 (j) The commissioners court by order may exclude an area  
21 from the district if the district has no outstanding bonds payable  
22 wholly or partly from sales and use taxes and the exclusion does not  
23 impair any outstanding district debt or contractual obligation.

24 SECTION 2. Section 387.005, Local Government Code, is  
25 amended to read as follows:

26 Sec. 387.005. GOVERNING BODY. (a) The commissioners court  
27 of the county in which the district is created by order shall

1 provide that:

2 (1) the commissioners court is the governing body of  
3 the district; or

4 (2) the commissioners court shall appoint a governing  
5 body of the district.

6 (b) A member of the governing body of the district  
7 [~~commissioners court~~] is not entitled to compensation for service  
8 [~~on the governing body of the district~~] but is entitled to  
9 reimbursement for actual and necessary expenses.

10 (c) A board of directors appointed by the commissioners  
11 court under this section shall consist of five directors who serve  
12 staggered terms of two years. To be eligible to serve as a  
13 director, a person must be a resident of the county in which the  
14 district is located. The initial directors shall draw lots to  
15 achieve staggered terms, with three of the directors serving  
16 one-year terms and two of the directors serving two-year terms.

17 SECTION 3. Subsection (a), Section 387.006, Local  
18 Government Code, is amended to read as follows:

19 (a) A district may:

20 (1) perform any act necessary to the full exercise of  
21 the district's functions;

22 (2) accept a grant or loan from:

23 (A) the United States;

24 (B) an agency or political subdivision of this  
25 state; or

26 (C) a public or private person;

27 (3) acquire, sell, lease, convey, or otherwise dispose

1 of property or an interest in property under terms determined by the  
2 district;

3 (4) employ necessary personnel; ~~and~~

4 (5) adopt rules to govern the operation of the  
5 district and its employees and property; and

6 (6) enter into agreements with municipalities  
7 necessary or convenient to achieve the district's purposes,  
8 including agreements regarding the duration, rate, and allocation  
9 between the district and the municipality of sales and use taxes.

10 SECTION 4. Subsection (b), Section 387.007, Local  
11 Government Code, is amended to read as follows:

12 (b) A district may not adopt a sales and use tax under this  
13 chapter if the adoption of the tax would result in a combined tax  
14 rate of all local sales and use taxes that would exceed the maximum  
15 combined rate prescribed by Sections 321.101 and 323.101, Tax Code,  
16 ~~[of more than two percent]~~ in any location in the district.

17 SECTION 5. Section 387.009, Local Government Code, is  
18 amended to read as follows:

19 Sec. 387.009. TAX RATE. The rate of a tax adopted under  
20 this chapter must be in increments of one-eighth~~[, one-fourth,~~  
21 ~~three-eighths, or one-half]~~ of one percent.

22 SECTION 6. Subsections (a), (b), and (c), Section 387.010,  
23 Local Government Code, are amended to read as follows:

24 (a) A district that has adopted a sales and use tax under  
25 this chapter may, by order and subject to Section 387.007(b):

26 (1) reduce~~[, change]~~ the rate of the tax or repeal the  
27 tax without an election, except that the district may not repeal the

1 sales and use tax or reduce the rate of the sales and use tax below  
2 the amount pledged to secure payment of an outstanding district  
3 debt or contractual obligation;

4 (2) increase the rate of the sales and use tax, if the  
5 increased rate of the sales and use tax will not exceed the rate  
6 approved at an election held under Section 387.003; or

7 (3) increase the rate of the sales and use tax to a  
8 rate that exceeds the rate approved at an election held under  
9 Section 387.003 after [~~if~~] the increase [~~change or repeal~~] is  
10 approved by a majority of the votes received in the district at an  
11 election held for that purpose.

12 (b) The tax may be changed under Subsection (a) in one or  
13 more increments of one-eighth of one percent [~~to a maximum of~~  
14 ~~one-half of one percent~~].

15 (c) The ballot for an election to increase [~~change~~] the tax  
16 shall be printed to permit voting for or against the proposition:  
17 "The increase [~~change~~] of a sales and use tax for the \_\_\_\_ County  
18 Assistance District No. \_\_\_\_ (insert name of district) from the rate  
19 of \_\_\_\_ [~~of one~~] percent (insert [~~one-fourth, three-eighths, or~~  
20 ~~one-half, as~~] appropriate rate) to the rate of \_\_\_\_ [~~of one~~] percent  
21 (insert [~~one-fourth, three-eighths, or one-half, as~~] appropriate  
22 rate)."

23 SECTION 7. Section 387.012, Local Government Code, is  
24 amended to read as follows:

25 Sec. 387.012. EFFECTIVE DATE OF TAX. The adoption of the  
26 tax, the increase or reduction [~~change~~] of the tax rate, or the  
27 repeal of the tax takes effect on the first day of the first

1 calendar quarter occurring after the expiration of the first  
2 complete quarter occurring after the date the comptroller receives  
3 a copy of the order of the district's governing body [~~notice of the~~  
4 ~~results of the election~~] adopting, increasing, reducing  
5 [~~changing~~], or repealing the tax.

6 SECTION 8. Subsection (d), Section 387.010, Local  
7 Government Code, is repealed.

8 SECTION 9. This Act takes effect immediately if it receives  
9 a vote of two-thirds of all the members elected to each house, as  
10 provided by Section 39, Article III, Texas Constitution. If this  
11 Act does not receive the vote necessary for immediate effect, this  
12 Act takes effect September 1, 2011.
