- 5 SECTION 1. Section 623.230, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 623.230. OPTIONAL PROCEDURE. This subchapter provides
- 8 an optional procedure for the issuance of a permit by the Victoria
- 9 County Navigation District for the movement of oversize or
- 10 overweight vehicles carrying cargo [on state highways located] in
- 11 Victoria County.
- 12 SECTION 2. Section 623.232, Transportation Code, is amended
- 13 to read as follows:
- 14 Sec. 623.232. ISSUANCE OF PERMITS. The Texas
- 15 Transportation Commission may authorize the district to issue
- 16 permits for the movement of oversize or overweight vehicles
- 17 carrying cargo only on the following [state] highways and roads
- 18 located in Victoria County:
- (1) Farm-to-Market Road 1432 between the Port of
- 20 <u>Victoria and State Highway 185;</u>
- 21 (2) State Highway 185 between U.S. Highway 59 and
- 22 McCoy Road;
- 23 (3) U.S. Highway 59, including a frontage road of U.S.
- 24 Highway 59, between State Highway 185 and Loop 463; and

- 1 (4) Loop 463 between U.S. Highway 59 and North Lone
- 2 Tree Road.
- 3 SECTION 3. Subsection (a), Section 623.234, Transportation
- 4 Code, is amended to read as follows:
- 5 (a) The district may collect a fee for permits issued under
- 6 this subchapter. The fees shall not exceed \$100 [\$80] per trip.
- 7 SECTION 4. Subsection (a), Section 623.235, Transportation
- 8 Code, is amended to read as follows:
- 9 (a) A permit issued under this subchapter must include:
- 10 (1) the name of the applicant;
- 11 (2) the date of issuance;
- 12 (3) the signature of the director of the district or
- 13 the director's designee;
- 14 (4) a statement of the kind of cargo being transported
- 15 [over Farm-to-Market Road 1432 to and from the Victoria Barge Canal
- 16 and up to but not past the intersection with State Highway 185], the
- 17 maximum weight and dimensions of the equipment, and the kind and
- 18 weight of each commodity to be transported, provided that the gross
- 19 weight of such equipment and commodities shall not exceed 140,000
- 20 $[\frac{125,000}{}]$ pounds;
- 21 (5) a statement of any condition on which the permit is
- 22 issued;
- 23 (6) a statement that the cargo shall only be
- 24 transported on a road designated under Section 623.232 [to and from
- 25 the Victoria Barge Canal using Farm-to-Market Road 1432 and may not
- 26 be transported over State Highway 185];
- 27 (7) the name of the driver of the vehicle in which the
