Subsections (a) and (c), Article 2.122, Code of 8 Criminal Procedure, are amended to read as follows: 9 10 (a) The following named criminal investigators of the United States shall not be deemed peace officers, but shall have the 11 powers of arrest, search, and seizure under the laws of this state 12 13 as to felony offenses only [under the laws of the State of Texas]: 14 Special Agents of (1)the Federal Bureau of 15 Investigation; (2) Special Agents of the Secret Service; 16 17 (3) Special Agents of the United States Immigration and Customs Enforcement; 18 19 (4) Special Agents of the Bureau of Alcohol, Tobacco, [and] Firearms and Explosives; 20 Special Agents of the United States [Federal] Drug 21 (5) 22 Enforcement Administration [Agency]; 23 (6) Inspectors of the United States Postal Inspection 24 Service;

16 (c) A Customs and Border Protection Officer or Border Patrol Agent of the United States Customs and Border Protection or an [a 17 Border Patrol agent,] immigration enforcement agent[<del>7</del>] 18 or deportation officer of the Department of Homeland Security is not a 19 20 peace officer under the laws of this state but, on the premises of a port facility designated by the commissioner of the United States 21 22 Customs and Border Protection as a port of entry for arrival in the United States by land transportation from the United Mexican States 23 24 into the State of Texas or at a permanent established border patrol 25 traffic check point, has the authority to detain a person pending transfer without unnecessary delay to a peace officer if the agent 26 27 or officer has probable cause to believe that the person has engaged

1 in conduct that is a violation of Section 49.02, 49.04, 49.07, or 2 49.08, Penal Code, regardless of whether the violation may be 3 disposed of in a criminal proceeding or a juvenile justice 4 proceeding.

5 SECTION 2. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2011.
