- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subsection (c), Section 1701.055, Occupations
- 6 Code, is amended to read as follows:
- 7 (c) Five members[, excluding ex officio members,]
- 8 constitute a quorum.
- 9 SECTION 2. Subsections (a) and (b), Section 1701.306,
- 10 Occupations Code, are amended to read as follows:
- 11 (a) The commission may not issue a license to a person [as an
- 12 officer or county jailer unless the person is examined by:
- 13 (1) a licensed psychologist or by a psychiatrist who
- 14 declares in writing that the person is in satisfactory
- 15 psychological and emotional health to serve as the type of officer
- 16 for which a license is sought; and
- 17 (2) a licensed physician who declares in writing that
- 18 the person does not show any trace of drug dependency or illegal
- 19 drug use after a [$\frac{physical examination_{\tau}}{r}$] blood test[$\frac{1}{\tau}$] or other
- 20 medical test.
- 21 (b) An agency hiring a person for whom a license [as an
- 22 officer or county jailer] is sought shall select the examining
- 23 physician and the examining psychologist or psychiatrist. The
- 24 agency shall prepare a report of each declaration required by

- 1 Subsection (a) and shall maintain a copy of the report on file in a
- 2 format readily accessible to the commission. A declaration is not
- 3 public information.
- 4 SECTION 3. Subsection (e), Section 1701.310, Occupations
- 5 Code, is amended to read as follows:
- 6 (e) A person trained and certified by the Texas Department
- 7 of Criminal Justice to serve as a corrections officer in that
- 8 agency's correctional institutions division is not required to
- 9 complete the training requirements of this section to be appointed
- 10 a part-time county jailer. Examinations under Section 1701.304 and
- 11 psychological [and physical] examinations under Section 1701.306
- 12 apply.
- 13 SECTION 4. Section 1701.353, Occupations Code, is amended
- 14 to read as follows:
- 15 Sec. 1701.353. CONTINUING EDUCATION PROCEDURES. (a) The
- 16 commission by rule shall adopt procedures to:
- 17 (1) ensure the timely and accurate reporting by
- 18 agencies and persons licensed under this chapter [peace officers]
- 19 of information related to training programs offered under this
- 20 subchapter, including procedures for creating training records for
- 21 license holders [individual peace officers]; and
- 22 (2) provide adequate notice to agencies and <u>license</u>
- 23 <u>holders</u> [peace officers] of impending noncompliance with the
- 24 training requirements of this subchapter so that the agencies and
- 25 <u>license holders</u> [peace officers] may comply within the 24-month
- 26 period or 48-month period, as appropriate.
- 27 (b) The commission shall require agencies to report to the

- commission in a timely manner the reasons that a license holder 1 2 [peace officer] is in noncompliance after the agency receives notice by the commission of the license holder's [peace officer's] 3 The commission shall, following receipt of an 4 noncompliance. agency's report or on a determination that the agency has failed to 5 report in a timely manner, notify the license holder [peace 6 7 officer] by certified mail of the reasons the license holder [peace officer] is in noncompliance and that the commission at the request 8 9 of the <u>license holder</u> [peace officer] will hold a hearing as provided by this subsection if the license holder [peace officer] 10 11 fails to obtain the required training within 60 days after the date the <u>license holder</u> [peace officer] receives notice under this 12 subsection. The commission shall conduct a hearing consistent with 13 Section 1701.504 if the license holder [peace officer] claims that: 14
- (1) mitigating circumstances exist; or
 (2) the license holder [peace officer] fa
- (2) the <u>license holder</u> [peace officer] failed to complete the required training because the <u>license holder's</u> [peace officer's] employing agency did not provide an adequate opportunity for the <u>license holder</u> [peace officer] to attend the required training course.
- 21 SECTION 5. Subchapter H, Chapter 1701, Occupations Code, is 22 amended by adding Section 1701.358 to read as follows:
- Sec. 1701.358. INITIAL TRAINING AND CONTINUING EDUCATION
 FOR POLICE CHIEFS. A police chief shall complete the initial
 training and continuing education required under Section 96.641,
 Education Code.
- 27 SECTION 6. Subsection (d), Section 1701.055, Occupations

- 1 Code, is repealed.
- 2 SECTION 7. The changes in law made by this Act to Section
- 3 1701.306, Occupations Code, apply to a license for which an
- 4 application is filed on or after the effective date of this Act. A
- 5 license application filed before the effective date of this Act is
- 6 governed by the law in effect on the date the application was filed,
- 7 and the former law is continued in effect for that purpose.
- 8 SECTION 8. This Act takes effect September 1, 2011.
