18	Sec. 8344.002. NATURE OF DISTRICT. The district is a	
19	municipal utility district created under Section 59, Article XVI,	
20	Texas Constitution.	
21	Sec. 8344.003. CONFIRMATION AND DIRECTORS' ELECTION	
22	REQUIRED. The temporary directors shall hold an election to	
23	confirm the creation of the district and to elect five permanent	
24	directors as provided by Section 49.102, Water Code.	

1 Sec. 8344.004. CONSENT OF MUNICIPALITY REQUIRED. The 2 temporary directors may not hold an election under Section 8344.003 3 until each municipality in whose corporate limits extraterritorial jurisdiction the territory added by Section 4 8344.005 is located has consented by ordinance or resolution to the 5 inclusion of land in the district. 6 7 Sec. 8344.005. TERRITORY ADDED. (a) The territory described by Section 2 of the Act enacting this chapter is added to 8 9 the district's territory as of the effective date of this section. (b) The boundaries and field notes contained in Section 2 of 10 the Act enacting this chapter form a closure. A mistake made in the 11 field notes or in copying the field notes in the legislative process 12 13 does not affect the district's: (1) organization, existence, or validity; 14 15 (2) right to issue any type of bond for the purposes 16 for which the district is created or to pay the principal of and 17 interest on a bond; 18 (3) right to impose a tax; or (4) legality or operation. 19 20 [Sections 8344.006-8344.050 reserved for expansion] SUBCHAPTER B. BOARD OF DIRECTORS 21 22 Sec. 8344.051. GOVERNING BODY; TERMS. (a) The district is 23 governed by a board of five elected directors. 24 (b) Except as provided by Section 8344.052, directors serve

1 (1) Erika Jasinski; 2 (2) Eric Blakely; 3 (3) Jonathan Parker; 4 (4) Meredith Powell; and (5) Rick Dolifka. 5 (b) Temporary directors serve until the earlier of: 6 7 (1) the date permanent directors are elected under Section 8344.003; or 8 9 (2) the fourth anniversary of the effective date of the Act enacting this chapter. 10 (c) If permanent directors have not been elected under 11 Section 8344.003 and the terms of the temporary directors have 12 13 expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that 14 15 expire on the earlier of: 16 (1) the date permanent directors are elected under 17 Section 8344.003; or 18 (2) the fourth anniversary of the date of 19 appointment or reappointment. 20 (d) If Subsection (c) applies, the owner or owners of a majority of the assessed value of the real property in the district 21 may submit a petition to the commission requesting that the 22 commission appoint as successor temporary directors the five 23 persons named in the petition. The commission shall appoint as 24 successor temporary directors the five persons named in the 25 26 petition.

- 17 municipality in whose corporate limits or extraterritorial
- 18 jurisdiction the road project is located.
- 19 (b) If a road project is not located in the corporate limits
- 20 or extraterritorial jurisdiction of a municipality, the road
- 21 project must meet all applicable construction standards,
- 22 <u>subdivision requirements</u>, and regulations of each county in which
- 23 the road project is located.
- (c) If a municipality or county will maintain and operate
- 25 the road, the municipality or county must approve the plans and
- 26 specifications of the road project.
- 27 (d) If the state will maintain and operate the road, the

- 1 Texas Transportation Commission must approve the plans and
- 2 specifications of the road project.
- 3 Sec. 8344.104. LIMITATION ON USE OF EMINENT DOMAIN. The
- 4 district may not exercise the power of eminent domain outside the
- 5 district to acquire a site or easement for:
- 6 (1) a road project authorized by Section 8344.102; or
- 7 (2) a recreational facility as defined by Section
- 8 <u>49.462, Water Code.</u>
- 9 [Sections 8344.105-8344.150 reserved for expansion]
- 10 SUBCHAPTER D. DIVISION OF DISTRICT INTO MULTIPLE DISTRICTS
- Sec. 8344.151. DIVISION OF DISTRICT; PREREQUISITES. The
- 12 district may be divided into two or more new districts only if the

- 14 (1) has no outstanding bonded debt; and
- 15 (2) is not imposing ad valorem taxes or assessments.

- Sec. 8344.153. LIMITATION ON AREA OF NEW DISTRICT. A new
- 22 district created by the division of the district may not, at the
- 23 time the new district is created, contain any land outside the

- 27 (2) the area added by Section 8344.005.
