- 5 ARTICLE 1. ENTITIES GIVEN 2013 SUNSET DATE
- 6 SECTION 1.01. GUARDIANSHIP CERTIFICATION BOARD. Section
- 7 111.003, Government Code, is amended to read as follows:
- 8 Sec. 111.003. SUNSET PROVISION. The board is subject to
- 9 Chapter 325, Government Code (Texas Sunset Act). Unless continued
- 10 in existence as provided by that chapter, the board is abolished and
- 11 this chapter expires September 1, 2013 [2015].
- 12 SECTION 1.02. WINDHAM SCHOOL DISTRICT WITHIN TEXAS
- 13 DEPARTMENT OF CRIMINAL JUSTICE. Chapter 19, Education Code, is
- 14 amended by adding Section 19.0021 to read as follows:
- Sec. 19.0021. LIMITED PURPOSE REVIEW. (a) As part of its
- 16 review of the Texas Department of Criminal Justice for the 83rd
- 17 Legislature, the Sunset Advisory Commission shall conduct a limited
- 18 purpose review of the structure, management, and operations of the
- 19 Windham School District.
- 20 (b) The Sunset Advisory Commission shall include in the

- 6 Sunset Act). Unless continued in existence as provided by that
- 7 chapter, the board is abolished and this subchapter expires
- 8 September 1, 2019 [2013].
- 9 ARTICLE 3. ENTITIES REMOVED FROM SPECIFIC SUNSET REVIEW
- 10 SECTION 3.01. BOARD OF DIRECTORS OF THE OFFICIAL CITRUS
- 11 PRODUCERS' PEST AND DISEASE MANAGEMENT CORPORATION. Section
- 12 80.028, Agriculture Code, is amended to read as follows:
- 13 Sec. 80.028. DISSOLUTION [SUNSET] PROVISION. (a) [The
- 14 board of directors of the official citrus producers' pest and
- 15 disease management corporation is subject to Chapter 325,
- 16 Covernment Code (Texas Sunset Act). Unless continued in existence
- 17 as provided by that chapter, the board is abolished and this chapter
- 18 expires September 1, 2021.
- 19 [(b)] The commissioner may order the dissolution of the
- 20 corporation at any time the commissioner determines that the
- 21 purposes of this chapter have been fulfilled or that the
- 22 corporation is inoperative and abandoned. Dissolution shall be
- 23 conducted in accordance with Section 80.014.
